Need for the Rule(s):

Based on specific criteria, this rule will allow transferring hunting tags to terminally ill individuals.

The proposed rule will provide a mechanism for qualifying terminally ill individuals to obtain controlled or limited hunt tags transferred from an immediate family member. To qualify for these tags individuals must have been diagnosed with a terminal illness by a licensed physician.

Statement of Cost of Compliance:

The proposed rules will affect state agencies, units of local government, and the public, respectively, as discussed below:
