

PHONE NUMBERS FOR WHOLESALE FISH DEALERS AND LIMITED FISH SELLERS

OREGON COMMODITY COMMISSIONS

Under the Oregon Department of Agriculture and Revised Statute 576, the Oregon Dungeness Crab Commission, Oregon Albacore Commission, Oregon Salmon Commission, and the Oregon Trawl Commission are authorized to represent Oregon fishermen and to carry out programs of market development, education, research, and promotion. Each Commission has an assessment for its fishery. Except for the Oregon Albacore Commission, the fishermen pay the assessment from the ex-vessel purchase amount--BUT THE ASSESSMENTS ARE DEDUCTED AND HELD IN TRUST BY THE WHOLESALE FISH DEALERS AND LIMITED FISH SELLERS. The Oregon Albacore Commission splits the assessment between the fisher and the dealer. Dealers and limited fish sellers forward assessments and reports to each Commission monthly.

If you plan to purchase (or as a limited fish seller to sell) crab, albacore tuna, troll salmon, or ocean trawl fish and shellfish you must contact the necessary Commission for information and report forms. Late reports and fees may be assessed penalties and interest. Addresses and phone numbers for the Commissions are:
