

# Proposed 2011 Raffle Hunts

## Bighorn Sheep

Bag limit: One (1) bighorn sheep ram  
 Season: August 13, 2011 – November 20, 2011  
 Open Area: Any area within Oregon wildlife unit boundaries where there is an authorized bighorn sheep season and tag in 2011.  
 Weapon: Any weapon legal for bighorn sheep hunting  
 Number of tags: One (1)

## Rocky Mountain Goat

Bag limit: One (1) Rocky Mountain goat  
 Season: September 1, 2011 – October 31, 2011  
 Open Area: Any area within Oregon wildlife unit boundaries where there is an authorized Rocky Mountain goat season and tag in 2011.  
 Weapon: Any weapon legal for Rocky Mountain goat hunting.  
 Number of tags: One (1)

## Pronghorn

Bag limit: One (1) pronghorn buck  
 Season: August 1, 2011 – September 30, 2011  
 Open Area: Any area within Oregon wildlife unit boundaries where there is an authorized pronghorn season and tag in 2011.  
 Weapon: Any weapon legal for pronghorn hunting.  
 Number of tags: One (1)

## A&H Statewide Deer Hunt

Bag limit: One (1) deer  
 Season: September 1, 2011 – November 30, 2011  
 Open Area: Any area within Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
 Weapon: Any weapon legal for deer hunting  
 Number of tags: One (1)

## A&H Governor's Statewide Combination Hunt

Bag limit: One (1) elk and one (1) deer  
 Season: September 1, 2011 – November 30, 2011  
 Open Area: Any area within Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures as defined in OAR Chapter 635, Division 065).  
 Weapon: Any weapon legal for elk and deer hunting  
 Number of tags: One (1) deer  
 One (1) elk

### **A&H Northeast Oregon Deer Hunt**

Bag limit: One (1) deer  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open to controlled buck deer rifle hunts within the following units: 44, 45, 47-64; (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for deer hunting  
Number of tags: One (1)

### **A&H Southeast Oregon Deer Hunt**

Bag limit: One (1) deer  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open to controlled buck deer rifle hunts within the following units: 46, 65-72, 74; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for deer hunting  
Number of tags: One (1)

### **A&H Central Oregon Deer Hunt**

Bag limit: One (1) deer  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open to controlled buck deer rifle hunts within the following units: 31-43, 73, 75-77; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for deer hunting  
Number of tags: One (1)

### **A&H Northeast Oregon Elk Hunt**

Bag limit: One (1) elk  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open to controlled elk rifle hunts within the following units: 44, 45, 47-64; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for elk hunting  
Number of tags: One (1)

### **A&H Central/Southeast Elk Hunt**

Bag limit: One (1) elk  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open to controlled elk rifle hunts within the following units: 31-43, 46, 65-72, 73-77; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for elk hunting

Number of tags: One (1)

### **A&H Western Oregon Elk Hunt**

Bag limit: One (1) elk  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area open within Western Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for elk hunting  
Number of tags: One (1)

### **A&H Statewide Elk Hunt**

Bag limit: One (1) elk  
Season: September 1, 2011 – November 30, 2011  
Open Area: Any area within Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065).  
Weapon: Any weapon legal for elk hunting
