

**Fiscal and Economic Impact Statement for the January 11, 2013 Hearing
In the Matter of Rules Relating to Food Fish Values Used
In Determining Damages for Commercial Fishing Violations**

Fiscal and economic impact:

Rule modifications are necessary to update existing food fish species' market values that will be used to assess damages resulting from commercial fishing violations in 2013. Revisions to this rule are based on actual prices paid for fish species by licensed fish dealers in 2012, with the exception of amounts mandated by Oregon Revised Statutes. The food fish values are used in instances where fish were illegally landed or not reported properly and a price cannot be determined.

Statement of Cost of Compliance

1. Impact on state agencies, units of local government and the public (ORS 183.335(2)(b)(E)):

The proposed rules will affect state agencies, units of local government and the public, respectively, as discussed below:

a. The only state agency that would be affected by adoption of these rules is the Oregon Department of Fish and Wildlife. No significant changes from the current levels of the department's operations or expenditures are expected as a result of the adoption of these rules.

b. No units of local government are expected to be affected by these rules. No significant changes from the current levels of any local agencies' operations or expenditures are expected as a result of the adoption of these rules.

c. The public could be affected by the adoption of these rules: The persons or businesses most likely to be affected are those who may be assessed damages for commercial fishing violations. The proposed amendments would replace the existing values with updated values. The changes could increase or decrease the damages depending on the species under consideration, and the market prices for those species in the last year. Overall, it is unlikely that there will be large changes in the magnitude of the total damages that would be incurred.

2. Cost of compliance effect on small business (ORS 183.336):

a. Estimate the number of small businesses and types of businesses and industries subject to the rule: Small businesses subject to these proposed rules would be commercial fishing outfits and commercial fish dealers. The number of individuals or businesses that purchased Oregon commercial fishing licenses in 2011 was 2,242 (1,897 resident and 345 nonresident) and the number of Oregon licensed fish dealers was 346. The vast majority of these license holders are small businesses, with less than 50 employees.

b. There would not be any projected reporting, recordkeeping and other administrative activities required for compliance, including costs of professional services, under these proposed rules.

c. No changes in equipment, supplies, labor and increased administration required for compliance under the proposed rules.

Most businesses affected by these rules are believed to be "small business."

The rules are believed to be fully compatible with legislative direction on the goals of wildlife management in Oregon.

We do not believe that a less intrusive or less costly alternative adaptation to only small business is consistent with the purpose of the rule.
