11 On Friday, **January 20, 2017 at 8:05 a.m.**, Chair Michael Finley called the Oregon  
12 **Fish and Wildlife Commission** (the Commission) meeting to order.

19 **Adopt Temporary Rules**

20 Curt Melcher, Director, requested the Commission ratify the following temporary rules.  
21 The four (4) temporary rules were previously adopted by the director under his  
22 emergency action authority.

23  
24 **1) 635-004-0355**

25 **In-season Adjustments to Commercial Nearshore Black Rockfish Fishery Trip**  
26 **Limits**

27 Adopted November 8, 2016: effective November 10, 2016 through December 31, 2016.

28 The amended rule implements changes to in-season trip limits for the Oregon  
29 commercial nearshore black rockfish fishery that were inadvertently omitted from a  
30 previous filing of this rule. Trip limits for black rockfish increased from 1600 to 2400  
31 pounds in period 4; from 1400 to 2200 pounds in period 5; and from 1000 to 1800  
32 pounds in period 6.

1           **2) 635-005-0505**

2           **Commercial Bay Dungeness crab Fishery Closes Due To Shellfish Health Closure**

3           Adopted November 21, 2016: effective November 21, 2016 through December 31,  
4           2016.

5           This amended rule closes the commercial bay Dungeness crab fishery due to  
6           issuance of a shellfish health closure by the Oregon Department of Agriculture. Existing  
7           permanent rule language does not adequately address closure of commercial  
8           Dungeness crab fisheries due to unsafe levels of bio toxins. Rule modifications are  
9           needed to close the fishery and to re-open the fishery when the shellfish health closure  
10          has been lifted.

11           **3) 635-005-0465**

12           **Commercial Dungeness crab Fishery Opener Delayed Due to Unsafe Levels of**  
13           **Domoic Acid**

14           Adopted November 23, 2016: effective November 23, 2016 through May 21, 2017.

15           This amended rule delays the opening of the 2016-2017 commercial Dungeness  
16           crab season in the Pacific Ocean and Columbia River due to elevated levels of the bio  
17           toxin domoic acid detected in samples of crab viscera during preseason testing. The  
18           season opening set in permanent rule is December 1. A new opening date for these  
19           fisheries has not been set, will depend on the results of further testing, and may differ  
20           regionally. Commercial Dungeness crab fisheries in bays and estuaries have already  
21           been closed in accordance with the provisions of Temporary OAR 635-005-0505(2) (e)  
22           which became effective November 21, 2016.

23           **4) 635-021-0090**

24           **Sprague River Closed to Angling January 23 through April 21, 2017**

25           Adopted January 17, 2017: effective January 23, 2017 through April 21, 2017.

26           This amended rule modifies the recreational season on the Sprague River in the  
27           Southeast angling zone. The Sprague River will be closed to all angling beginning  
28           January 23 through April 21, 2017. Closing the Sprague River during this time frame will  
29           protect redband trout from angling pressure and mortality associated with handling and  
30           harassment. The season will reopen to angling on April 22, 2017. Adfluvial redband  
31           trout are repeat spawners, thus the excessive stress placed on these fish from  
32           spawning and harassment by anglers would reduce their chances of survival and have  
33           repercussions on future fisheries in Upper Klamath Lake and the Williamson River.

34           Action: Commissioner Webber moved to ratify the three temporary rules set out on  
35           today's tan agenda, plus a fourth temporary rule, 635-021-0090 dealing with the closure  
36           on Sprague River. Commission Chair Finley seconded the motion, and the motion  
37           carried unanimously.

6 Commissioner Bittle stated a potential conflict of interest. The nature of the potential  
7 conflict is ownership of a boat company. (8:17 on recording)  
8

9 *Discussion:*  
10 *Commissioner Akenson read the following statement into the record.*  
11

12 *Columbia Fisheries Management and Reform is a very complex issue. I want to thank*  
13 *ODFW staff for continuing to provide the Commission with additional information,*  
14 *analyses, and clarifications. Your efforts and expertise have helped guide us to the best*  
15 *solution for the state of Oregon.*  
16

17 *It is time for our Commission to finalize the Columbia River Fisheries Reform Policy for*  
18 *Oregon and Washington. In 2012 I voted to support the Reform Policy, including its*  
19 *transition period, additional funding for implementation, and adaptive management to*  
20 *address unknow factors that could make the original concept nonworkable relative to*  
21 *the guiding principles. I approach this decision as a conservationist, a professional fish*  
22 *and wildlife biologist, and a citizen concerned with the interests of all Oregonians. My*  
23 *conclusions are primarily based on available data, information, analysis, and science*

1 *that addresses the Commission’s obligations as outlined by the Oregon Legislature in*  
2 *ORS 508.980.*

3  
4 *The original ideals of the Columbia River Fisheries Reform Policy have not been met*  
5 *during the transition period. Therefore, adaptive management measures must be*  
6 *incorporated in the final Policy.*

7  
8 *First, during the transition no alternative gears tested were determined by ODFW to be*  
9 *significantly more effective or economically viable than the current use of gillnets or*  
10 *tangle nets selectively used in time, place, and mesh size to minimize mortality on wild*  
11 *stocks. Only in one potential new “conservation fishery” was a seine determined to be*  
12 *the best method for targeted removal of excess hatchery fish headed to wild fish*  
13 *spawning areas. I realize “removing gillnets from the mainstem Columbia River” was a*  
14 *strong motivator for many people in favor of reform, but simply replacing one source of*  
15 *mortality for another does not enhance conservation of ESA listed and other wild stock*  
16 *of salmonids. This misconception about conservation was widely promoted by many*  
17 *recreational fishers and industry representatives who provided testimony. In reality,*  
18 *commercial and recreational fisheries are managed through allocation of “ESA*  
19 *Impacts”. If the allocation is 60:40 recreational fishers can kill 60 percent of the ESA fish*  
20 *allowed by federal rules as incidental take for Oregon Columbia Fisheries, and*  
21 *commercial fishers can kill 40 percent of the allowed ESA fish mortality. If the allocation*  
22 *changes to 80:20 then recreational fishers kill 80 percent and commercial fishers kill 20*  
23 *percent of the allowable number of endangered fish. The number of endangered fish*  
24 *incidentally killed by the combination of fisheries does not change with changing*  
25 *allocations. A dead fish is a dead fish, whether it is killed by a gill net, alternative gears,*  
26 *or hook and line recreational fishers. In other words, an allocation change itself did not*  
27 *provide additional conservation benefits to ESA listed fish survival.*

28  
29 *Second, we are obligated to “Optimize overall economic benefits to this state” and*  
30 *“Enhance the economic viability of Oregon’s recreational and commercial fisheries and*  
31 *the communities that rely on these fisheries.” Of the five scenarios analyzed by ODFW*  
32 *staff only two scenarios meet the minimum standard of enhancing economic viability for*  
33 *commercial fishers (Salmon for All (SFA) and Enhanced Commercial Rebalancing),*  
34 *while all five meet the standard for recreational fishers. Staff modeling indicates that*  
35 *overall economic benefits were greatest for the SFA scenario. There have been some*  
36 *differences in understanding how economic “effects” of a policy change is evaluated. By*  
37 *definition, a comparison of a change in policy MUST be made between the expected*  
38 *economic values WITH and WITHOUT policy changes. During the transition run sizes*  
39 *have been larger than pre-policy. This has resulted in increased economic benefits to*  
40 *both groups, but this is not because of a change in policy, instead, ODFW staff*  
41 *demonstrated a mathematical correlation between run size and annual economic*  
42 *benefits.*

43  
44 *Third, this policy is to “contribute to native fish conservation and recovery.” Staff’s new*  
45 *concept of a “conservation set aside” is a prime example of a novel idea to make real*  
46 *progress with conservation using both fisheries as conservation tool, and not pointing*  
47 *fingers at the other side. We need more innovative ideas like these. We need to focus*



1 *more on conservation of ESA listed species and other wild stocks and less on allocation*  
2 *changes. The sooner listed species can be recovered, the sooner all fisheries will*  
3 *experience less limitations on harvest opportunities.*

4  
5 *Analysis of the transition period has demonstrated that the original policy we were*  
6 *working toward is not viable and does not comply with ORS 508.980, failing in economic*  
7 *terms and performance of alternative gear types. This may be discouraging for some*  
8 *fishers, but we need to use facts, not opinions, to guide Columbia River fisheries*  
9 *management. The best alternative all around is somewhere between the SFA scenario*  
10 *and the Enhanced Commercial Rebalance. They both enhance recreational and*  
11 *commercial fisheries economics and provide the best overall economics of all*  
12 *scenarios. Although they continue mainstream gillnet or tangle net fisheries, not all*  
13 *alternatives were found better. The SFA and Enhanced Commercial Rebalance*  
14 *scenarios are not concurrent with Washington, but it is more important for Oregon to do*  
15 *what best for Oregonians. We must comply with the laws of Oregon.*

16  
17 *Action:*

18 Commissioner Webber moved to amend applicable OAR to concur with Washington  
19 except for the two year limitation, with the barbless regulation change, and Young's Bay  
20 control zone elimination. Chair Finley seconded the motion.

21  
22 Chair Finley withdrew his second for this motion. Commissioner Bittle seconded the  
23 motion. Motion failed with a vote of: in favor (2) Webber, Bittle; opposed: (5) Anderson,  
24 Buckmaster, Wolley, Akenson, and Finley.

25  
26 Commissioner Anderson proposed an alternate motion.

27  
28 Commissioner Anderson moved to adopt the Enhanced Commercial Rebalance Plan as  
29 outlined in exhibit D with the following change; the continuation of the Young's Bay  
30 control zone. Commissioner Buckmaster seconded the motion.

31  
32 Motion passed with a vote of: in favor (4) Anderson, Buckmaster, Wolley, Akenson;  
33 opposed (3) Webber, Bittle, Finley.

34  
35 **OTHER BUSINESS**

36  
37 Chair Michael Finley adjourned the meeting at 7:35 p.m.

38
