Director Melcher,

I am writing today in frustration and concern that ODFW continues to prioritize conservation of "game" animals in Oregon at the expense of other wildlife, many of which actually are in danger. An example is the Pine Marten - I understand that there are approximately 100 or less of these ancient forest animals in Oregon, and yet ODFW has expressed only "concern" for their wellbeing, stating that their locations and habitat needs "should" be considered in forestry management decisions. This would seem hardly adequate for the situation. As an Oregon citizen who values our wildlife, I would urge you to rectify the management of the Pine Marten by upgrading it's status to "endangered" and create appropriate, enforceable management practices to ensure it's survival.

Dear ODFW Commission:

I am writing you to urge you to take two actions regarding the imperiled Humboldt marten.

First, I would ask you to ban trapping practices that could kill martens in the central and southern coastal areas of Oregon. This preliminary step is critical to ensuring that the species does not go extinct. Recent studies have concluded that the loss of just a few individual martens annually could lead to imminent extinction of the species.

Second, I am requesting that you list the Humboldt marten as an "endangered species." The current immediate threats that highways and trapping pose to the species fall under state agency jurisdiction, and your leadership is needed to ensure the marten's recovery.
