30 **Adopt Temporary Rules**

31 Curt Melcher, Director, requested the Commission ratify the following temporary rules.
32 The twenty-seven (27) temporary rules were previously adopted by the director under his
33 emergency action authority.

34
35 **1.) 635-019-0090**

36 **Spring Sport Fishery in the Umatilla River**

37 Adopted June 7, 2018: effective June 11, 2018 through July 1, 2018

38 On the Umatilla River from Hwy 730 Bridge to Three-mile Dam, Spring Chinook
39 fishery opens for hatchery spring Chinook salmon June 11 – June 30, 2018. The daily
40 bag limit is two (2) adult and five (5)-jack hatchery spring Chinook salmon.

41
42 **2.) 635-039-0085**

43 **Sport Pacific Halibut All-Depth Season from Leadbetter Point, WA to Cape Falcon, OR Reopening**

44 Adopted June 5, 2018: effective June 21, 2018 through September 30, 2018

1 This amended rule reopens the recreational all-depth Pacific halibut season for
2 one day, Thursday, June 21, 2018, in the area between Leadbetter Point, Washington
3 and Cape Falcon, Oregon. The National Oceanic & Atmospheric Administration (NOAA),
4 International Pacific Halibut Commission (IPHC), Washington Department of Fish and
5 Wildlife (WDFW), and the Department (ODFW) conferred on June 5, 2018 and
6 determined that enough quota remained to reopen all Washington subareas, including
7 the Columbia River Subarea for an additional day. This will increase angler opportunity
8 to reach the harvest quota for the subarea.
9

10 **3.) 635-023-0128**

11 **Columbia River Recreational Summer Chinook Seasons Established**

12 Adopted June 13, 2018: effective June 16, 2018 through July 31, 2018

13 This amended rule establishes retention periods for adult summer Chinook in
14 mainstem Columbia River summer recreational fisheries that begin June 16, 2018.
15

16 **4.) 635-014-0090**

17 **Trask River Angling Regulations Modified Effective June 18, 2018**

18 Adopted June 13, 2018: effective June 18, 2018 through July 31, 2018

19 The 2018 run of spring Chinook salmon to the Tillamook Bay basin and Trask
20 River has been much reduced over recent years. Angling success has been relatively
21 poor, and all signs point to a low return of spring Chinook to the basin. This regulation
22 modification will close the Trask River in the vicinity of Trask Hatchery (200 feet
23 upstream and 900 feet downstream of Gold Creek- "hatchery hole") to angling earlier
24 than scheduled. This action is necessary to protect hatchery spring Chinook that hold in
25 the river adjacent to the hatchery over the summer prior to being collected for spawning.
26 In addition to low numbers of fish present so far, river flows are very low and with hot
27 summer weather approaching, these conditions could lead to higher than average pre-
28 spawning mortality, further jeopardizing our ability to collect sufficient brood stock for
29 hatchery production.
30

31 **5.) 635-006-0212, 635-006-0215, 635-006-0225**

32 **Commercial Sales of Dressed Salmon and Steelhead by Columbia River Treaty
33 Tribal Fishers Allowed**

34 Adopted June 19, 2018: effective June 19, 2018 through December 15, 2018

35 These amended rules allow commercial sales of gilled and gutted Columbia River
36 salmon and steelhead caught by Treaty tribal members to wholesale fish dealers,
37 canners, and buyers. Modifications also require wholesale fish dealers, canners, and
38 buyers to report totals of fish purchased in landed weights on the Fish Receiving Ticket.
39 Any gilled and gutted salmon and steelhead trout must be reported using the appropriate
40 conversion code (60) which applies a conversion factor of 1.17 to convert dressed
41 pounds to round pounds.
42

43 **6.) 635-065-0772**

44 **Tags for Terminally Ill Children and Disabled Veterans**

45 Adopted: June 20, 2018 Effective Dates: June 20, 2018 through December 16, 2018

1 Senate Bill 1517 authorized the Department of Fish and Wildlife to annually issue a
2 limited number of big game hunting tags without charge to nonprofit organizations for
3 use by veterans qualifying as disabled. Current rules provide limited deer, elk, pronghorn
4 antelope, and black bear tags to host organizations for granting hunting adventures to
5 terminally ill children. The proposed rule will rely on the nonprofit organizations to filter
6 the interest from disabled vets to match intent of tags going to combat veterans with
7 some fairly severe limitations and life challenges.
8

9 **7.) 635-004-0355**

10 **Commercial Nearshore Fishery In-season Trip Limit Adjustments for Periods 4 - 6**

11 Adopted June 22, 2018: effective July 5, 2018 through December 31, 2018

12 This amended rule implements in-season trip limit adjustments for the State
13 Commercial Nearshore fishery for Periods 4 - 6. Blue/Deacon Rockfish will be decreased
14 from 300 to 100 pounds, Other Nearshore Rockfish will be decreased from 450 to 250
15 pounds, and Cabezon will be reduced to 500 pounds from 2,500 pounds in periods 4 and
16 5 and from 2,000 pounds in period 6.
17

18 **8.) 635-039-0090**

19 **Daily Marine Fish Bag Limit Reduced from Five (5) to Four (4) Fish per Angler**

20 Adopted June 26, 2018: effective July 1, 2018 through December 22, 2018

21 This amended rule reduces the daily general marine fish bag limit from five (5) fish
22 per angler to four (4) beginning at 12:01 a.m. on July 1, 2018.
23

24 **9.) 635-039-0085**

25 **Sport Pacific Halibut Nearshore Season from Leadbetter Point, WA to Cape
26 Falcon, OR Closing**

27 Adopted June 28, 2018: effective June 30, 2018 through September 30, 2018

28 This amended rule closes the recreational nearshore Pacific halibut season at
29 11:59 pm on Saturday, June 30, 2018, in the area between Leadbetter Point,
30 Washington and Cape Falcon, Oregon. The National Oceanic & Atmospheric
31 Administration (NOAA), International Pacific Halibut Commission (IPHC), Washington
32 Department of Fish and Wildlife (WDFW), and the Department (ODFW) conferred on
33 June 27, 2018 and determined that the entire subarea quota has been taken.
34

35 **10.) 635-023-0128**

36 **Columbia River Recreational Summer Chinook Seasons Established**

37 Adopted June 28, 2018: effective July 1, 2018 through July 31, 2018

38 This amended rule prohibits retention periods for adult summer Chinook and
39 allows adult sockeye in mainstem Columbia River summer recreational fisheries that
40 begin July 1, 2018
41

42 **11.) 635-041-0076**

43 **Treaty Indian Commercial Summer Salmon Fisheries Set**

44 Adopted June 28, 2018: effective July 2, 2018 through July 31, 2018

1 These amended rules authorize the sales of fish caught in Treaty Indian
2 commercial summer salmon gillnet and/or hook-and-line fisheries both above and below
3 Bonneville Dam in the Columbia River beginning 6:00 a.m. Monday, July 2, 2018.
4 Modifications are consistent with action taken June 28, 2018 by the Departments of Fish
5 and Wildlife for the States of Oregon and Washington in cooperation with the Columbia
6 River Treaty Tribes at a meeting of the Columbia River Compact.

7
8 **12.) 635-042-0145**

9 **Modify 2018 White Sturgeon Possession Limit for the Youngs Bay Select Area**

10 Adopted June 28, 2018: effective July 2, 2018 through July 26, 2018

11 This amended rule modifies the 2018 summer white sturgeon possession and
12 sales limit from two to three for the Youngs Bay Select Area. Modifications are consistent
13 with action taken June 28, 2018 by the Oregon Department of Fish & Wildlife.

14
15 **13.) 635-042-0160, 635-042-0170**

16 **Modify 2018 Commercial Seasons for Columbia River Select Areas**

17 Adopted June 28, 2018: effective July 2, 2018 through July 26, 2018

18 These amended rules modify the 2018 summer commercial salmon seasons for
19 the Tongue Point/South Channel, and the Blind/Knappa Sloughs Select Areas.
20 Modifications are consistent with action taken June 28, 2018 by the Departments of Fish
21 & Wildlife for the States of Oregon and Washington at a meeting of the Columbia River
22 Compact.

23
24 **14.) 635-060-0000, 635-060-0023**

25 **Allow Purchase of 700 Series Preference Points July 1 through November 30, 2018**

26 Adopted: June 28, 2018 Effective Dates: June 28,, 2018 through November 30, 2018

27 OAR 635-060-0000 by reference and OAR 635-060-0023(12) (a), do not authorize
28 the purchase of 700 Series (Spring Bear) preference points when preference points for
29 other series are available July 1-November 30. Temporary rules are needed to allow
30 hunters to purchase one 700 Series preference point from July 1 through November 30,
31 2018, if they did not go through the 2018 Spring Bear (700 Series) controlled hunt draw
32 or purchase a 2018 tag for the SW Oregon Limited 700 Series Hunt.

33
34 **15.) 635-002-0035**

35 **Destruction of Forfeited Firearms from Wildlife Law Violations**

36 Adopted: June 28, 2018 Effective Dates: June 28, 2018 through December 24, 2018

37 OAR 635-002-0035 designates that seized equipment from wildlife law violations
38 which are then court ordered forfeiture will be sold with profits deposited into the
39 Common School fund. The proposed temporary rule makes an exception for any
40 forfeited firearm which would be destroyed by incineration. This change will prevent any
41 firearm used in a crime to have the potential in being used in any other illegal activity.

42
43
44 **16.) 635-005-0387**

45 **Netarts Bay Commercial Cockle Clam Fishery Closes**

1 Adopted July 5, 2018: effective July 9, 2018 through December 31, 2018

2 This amended rule closes the Netarts Bay commercial cockle fishery at 12:01
3 a.m. July 9, 2018 due to a projected attainment of the 22,000 pound annual harvest
4 quota allowed under bay clam catch limits. Modifications are consistent with
5 requirements described in OAR 635-005-0387 section (1).

6
7 **17.) 635-023-0128**

8 **Columbia River Recreational Summer Chinook Seasons Modified**

9 Adopted July 5, 2018: effective July 7, 2018 through July 31, 2018

10 This amended rule prohibits retention for adult summer Chinook in the mainstem
11 Columbia River upstream of Bonneville Dam effective July 7, 2018.

12
13 **18.) 635-041-0076**

14 **Treaty Indian Commercial Summer Salmon Fisheries Set**

15 Adopted July 10, 2018: effective July 11, 2018 through July 31, 2018

16 These amended rules authorize the sales of fish caught in Treaty Indian
17 commercial summer salmon gillnet and/or hook-and-line fisheries both above and below
18 Bonneville Dam in the Columbia River beginning 6:00 a.m. Wednesday, July 11, 2018.
19 Modifications are consistent with action taken July 10, 2018 by the Departments of Fish
20 and Wildlife for the States of Oregon and Washington in cooperation with the Columbia
21 River Treaty Tribes at a meeting of the Columbia River Compact.

22
23 **19.) 635-005-0355**

24 **Tillamook Bay Commercial Gaper Clam Dive Fishery Closes**

25 Adopted July 17, 2018: effective July 22, 2018 through September 27, 2018

26 Amended rule closes the Tillamook Bay commercial gaper clam dive fishery at
27 12:01 a.m. July 22, 2018 due to a projected attainment of the 235,000 pound annual
28 harvest quota allowed under bay clam catch limits. Modifications are consistent with
29 requirements described in OAR 635-005-0355.

30
31 **20.) 635-016-0090**

32 **Southwest Zone Regulation Changes Due to Drought Conditions and Two-Rod
33 Fisheries Set.**

34 Adopted July 24, 2018: effective July 28, 2018 through September 30, 2018

35 These amended rules will allow the use of up to two-rods with a valid 2018 two-
36 rod validation in the Rogue River and Coos Bay, Coos River. Beginning July 28, 2018
37 the Umpqua River mainstem is closed to angling within a 200-foot radius from the
38 mouths of all tributaries.

39
40 **21.) 635-041-0045, 635-041-0063, 635-041-0075**

41 **Sales from Columbia River Treaty Indian Fall Commercial Fisheries Authorized**

42 Adopted July 26, 2018: effective July 27, 2018 through December 31, 2018

43 These amended rules authorize the sales of fish caught in fall Treaty tribal
44 platform commercial fisheries set for the Columbia River from 12:01 a.m. August 1
45 through 6:00 p.m. December 31, 2018. In addition, sales of white sturgeon landed setline

1 fisheries in Bonneville and John Day pools are allowed. Modifications are consistent with
2 action taken July 26, 2018 by the Departments of Fish & Wildlife for the States of Oregon
3 and Washington in cooperation with the Columbia River Treaty Tribes at a meeting of the
4 Columbia River Compact.

5
6 **22.) 635-018-0090**

7 **Metolius Pond Sport Fishing Regulations**

8 Adopted July 27, 2018: effective July 31, 2018 through December 31, 2018

9 This amended rule allows the sport harvest of rainbow trout at the Metolius Pond.
10 Angling is limited to youth and disabled anglers. Daily bag limit is two fish per angler.

11
12 **23.) 635-042-0145**

13 **Set Fall Commercial Seasons in the Select Areas of the Columbia River.**

14 Adopted July 26, 2018: effective August 1, 2018 through October 31, 2018

15 These amended rules establish the 2018 fall commercial salmon seasons for
16 Select Area fisheries in the Columbia River.

17
18 **24.) 635-023-0130**

19 **2018 Columbia River Fall Recreational Salmon Seasons Set**

20 Adopted July 31, 2018: effective August 1, 2018 through December 31, 2018

21 This amended rule sets the 2018 fall recreational Chinook salmon season
22 regulations for the mainstem Columbia River, effective August 1, 2018. Modifications,
23 based on *2018 Non-Treaty Columbia River Summer/Fall Fishery Allocation Agreement*
24 (4/26/18) that was developed following the Pacific Fisheries Management Council
25 (PFMC) and North of Falcon (NOF) meetings. Fall fisheries in 2018 are structured to
26 optimize the harvest of Chinook, coho and steelhead within Endangered Species Act
27 (ESA) limits and to provide a balanced opportunity for the fishers.

28
29 **25.) 635-011-0100**

30 **Radio-Tagged Chinook salmon May Be Retained in the Northwest Zone**

31 Adopted July 31, 2018: effective August 1, 2018 through December 31, 2018

32 The amended rule allows the retention of radio-tagged Chinook salmon in the
33 Northwest Zone. Rule modifications allow retention of radio-tagged Chinook salmon in
34 conjunction with a radio telemetry study in the Tillamook Bay.

35
36 **26.) 635-016-0090**

37 **Fishing Period Restrictions Set in the North Umpqua River of the Southwest Zone.**

38 Adopted July 27, 2018: effective August 6, 2018 through September 30, 2018

39 This amended rule will set a restricted daily time limit on fishing in the “fly-only” section of
40 the North Umpqua River. Beginning August 6, 2018, all fishing will need to cease from
41 2:00 p.m. to one hour before sunrise.

42
43 **27.) 635-042-0160, 635-042-0170, 635-042-0180**

44 **Set Fall Commercial Seasons in the Select Areas of the Columbia River.**

45 Adopted July 26, 2018: effective August 27, 2018 through December 31, 2018

1 These rules establish the 2018 fall commercial salmon seasons for Select Area
2 fisheries in the Columbia River beginning August 1, 2018 through December 31, 2018.

3
4 Action:

5 Commissioner Webber moved to ratify the twenty-seven (27) temporary rules set forth in
6 the today's tan agenda. Commissioner Buckmaster seconded the motion, and the motion
7 carried unanimously, five (5) in favor. Bittle excused

8
9 Commissioner Akenson proposed to direct staff to amend the rule to close Columbia
10 River sport fishing in the Deschutes River cool water sanctuary when weekly average
11 water temperatures at Bonneville Dam exceed 68 degrees Fahrenheit. This rule is to
12 prevent excess mortality of migrating steelhead and salmon during periods of hot water
13 temperatures when fish are most vulnerable. The discretion to set the cool water
14 sanctuary boundary is provided to staff. With the following guidance "The Columbia River
15 within areas at and adjacent to the mouth of the Deschutes River. The closed area are
16 along the Oregon side of the Columbia River and extend out to the midstream from a half
17 mile above the intersection of the upper banks of the Deschutes with the Columbia River
18 to a point one mile downstream from the intersection of the lower banks of the
19 Deschutes with the Columbia river. All such points are posted with deadline markers.
20 Additionally, the Deschutes River from its confluence with the Columbia River upstream
21 to the deadline marker below Moody Rapids shall be closed". Columbia River
22 Commissioner Wolley seconded the motion, and the motion carried unanimously, five (5)
23 in favor. Bittle excused
