Little Sheep Wildlife Area (Wallowa County)

The Little Sheep Wildlife Area is open to wildlife-oriented public use unless otherwise excluded or restricted.

(1) Discharging of firearms is prohibited except while hunting during authorized game bird and game mammal seasons.

(2) Camping is prohibited.

(3) Open fires are prohibited.

(4) The wildlife area is closed to the public between 10 pm and 4 am.

(5) Domestic sheep and goats are prohibited.

Lower Deschutes Wildlife Area (Sherman/Wasco Counties)

The Lower Deschutes Wildlife Area is open to wildlife-oriented public use compatible with the goals and objectives contained in the 2009 Lower Deschutes Wildlife Area Management Plan unless otherwise excluded or restricted by the Deschutes River Scenic Waterway Rules and the following additional rules:

(1) Open to the discharge of firearms only while hunting big game and game birds during authorized seasons or by permit; except that discharge of firearms is prohibited within the scenic waterway boundary from the third Saturday in May through August 31.

(2) Unauthorized motor vehicle use is prohibited.

(3) Horses and horseback riding are prohibited except by access permit issued by OPRD.

(4) Open fires are prohibited except as specified under the Scenic Waterway rules.

(5) Camping is prohibited on river islands, areas posted "camping prohibited" within the Deschutes River Scenic Waterway, and on state lands outside the Deschutes River Scenic Waterway in the Lower Deschutes Wildlife Area (Deschutes Scenic Waterway is an area extending 1/4-mile away from each bank of the river).

1 Exception: Camping is allowed on the Woosley Tract from three days prior to the opening of controlled buck
2 deer season through February 28, and shall not exceed a total of 14 days during any 30-day period.

3 (6) Public access to the Woosley Tract is only allowed from the Deschutes River through adjacent
4 Bureau of Land Management lands.

5 **(7) Domestic sheep and goats are prohibited.**

10 **Riverside Wildlife Area (Harney/Malheur Counties)**

11 The Riverside Wildlife Area is open to wildlife-oriented public use compatible with the goals and
12 objectives contained in the 2009 (updated 2019) Riverside Wildlife Area Management Plan unless otherwise
13 excluded or restricted by the following rules:

14 (1) Camping is prohibited.

15 (2) Open fires are prohibited.

16 (3) Motorized vehicle travel is only allowed on open roads or parking areas.

17 **(4) Domestic sheep and goats are prohibited.**

22 **St. Louis Ponds (Marion County)**

23 (1) St. Louis Ponds is that area of posted Department lands located in Sections 21, 22, 27, and 28,
24 Township 5 South, Range 2 West of the Willamette Meridian in Marion County and containing 222 acres
25 more or less.

26 (2) In the area described in section (1) of this rule it is unlawful to:

27 (a) **Access** [~~Use~~] the area for any purpose between **9 pm and 6 am from April 1 through September**
28 **30, or between 7 pm and 6 am from October 1 through March 31;** [~~one hour after sunset and one hour~~
29 ~~before sunrise~~]

30 (b) Use any floating craft on any pond;

31 (c) Swim or otherwise enter any pond;

32 (d) Build open fires;

33 (e) Discharge rifles and pistols;

1 (f) Discharge shotguns except during open seasons between the beginning of pheasant season and the end
2 of waterfowl season, or during dog trials authorized by Department permit;

3 (g) Operate motor vehicles off established roads;

4 (h) Violate the terms of any permit issued by the Department.

5 (3) No person shall possess or use any shot other than federally-approved nontoxic shot at any time.

6 (4) Trapping is prohibited.

11 **Phillip W. Schneider Wildlife Area (Grant County)**

12 The Phillip W. Schneider Wildlife Area is open to wildlife-oriented public use compatible with the goals
13 and objectives contained in the 2006 (updated 2017) Phillip W. Schneider Wildlife Area Management Plan
14 unless otherwise excluded or restricted by the following rules:

15 (1) Motorized vehicle travel is only allowed on open roads or parking areas and up to 300 feet off open
16 roads for the purpose of moving to and from campsites. Some roads are closed seasonally from December 1
17 through April 14.

18 (2) Camping along the South Fork John Day road is open yearlong. On the remainder of the wildlife area
19 camping is prohibited except during the period April 15 through November 30. Camping shall not exceed a
20 total of 14 days during any 30-day period.

21 (3) Campfires or open burning is prohibited except at campsites. Open fires are prohibited during
22 designated fire closures.

23 (4) The area is closed to entry during the period of February 1 through April 14, including BLM land
24 within the exterior boundaries of the Wildlife Area.

25 (5) ODFW Wildlife Area Parking Permit required.

26 **(6) Domestic sheep and goats are prohibited.**

31 **Wenaha Wildlife Area (Wallowa County)**

32 The Wenaha Wildlife Area is open to wildlife-oriented public use compatible with goals and objectives
33 contained in the 2007 (updated 2017) Wenaha Wildlife Area Management Plan unless otherwise excluded or
34 restricted by the following rules:

1 (1) The area is open to the public from April 1 through December 31, except by access permit issued by
2 ODFW. Exceptions: Year-round public access is permitted at designated camping areas, (headquarters and
3 Griz Flat), on department land along the Wenaha River, and between the Grande Ronde river road and the
4 Grande Ronde River from the Redmond grade bridge below Troy to the mouth of Wildcat Cr.

5 (2) Motorized vehicle travel is only allowed on open roads or parking areas and up to 300 feet off open
6 roads for the purpose of moving to and from designated campsites.

7 (3) Camping is prohibited except in designated campsites and shall not exceed a total of 14 days during
8 any 30-day period.

9 (4) Campfires or open burning is prohibited except at campsites. Open fires are prohibited during
10 designated fire closures.

11 (5) Discharging of firearms is prohibited except while hunting during authorized game bird and game
12 mammal seasons, or at the Griz Flat muzzleloader range in accordance with posted rules.

19 PROCEDURES FOR ESTABLISHING, OPERATING, DISCONTINUING 20 AND SUSPENDING LICENSE AGENCIES

23 **Issuing Documents**

24 (1) Licensing documents may be obtained online through the Department's Electronic Licensing Systems,
25 through the Department or its agents. Unless otherwise indicated in specific Department-issued instructions,
26 the Department will not issue any privilege until it receives the required fee through an acceptable payment
27 method.

28 (2) With the exceptions noted in sections (3) and (4) below, a resident is ~~[one]~~ **a person** who has
29 physically ~~[dwelled]~~ **resided** in Oregon ~~[continuously]~~ for ~~[the]~~ **not less than six consecutive** months
30 **immediately** prior to ~~[applying]~~ **the date of making application** for a license, **tag or permit**. ~~Temporary~~
31 ~~absences from Oregon during that time period do not defeat a person's residency so long as such absences~~
32 ~~were not for the purpose of establishing residency outside Oregon.~~ **Resident does not include a person who**
33 **merely owns real property or pays property taxes in this state; or who claims resident privileges in**
34 **another state or country for any purpose.** This is the legal standard for purchasing a resident license.

1 (a) To implement the legal standard, the applicant must attest at the time residency information is
2 provided to the Department: “I hereby attest and declare that the information provided is true and that I can
3 provide evidence to support this information upon request.”

4 (b) A resident senior citizen recreational fishing and hunting license, is available to residents of Oregon
5 who have reached the age of 70 and have resided in Oregon no less than five years.

6 (3) The legislature has waived the six month requirement for certain classes of persons:

7 (a) Active members the uniformed services permanently assigned to active duty in Oregon (and their
8 spouses and dependent children). This includes, but is not limited to, those who serve as crew members of
9 ships that have an Oregon port or shore establishment as their home port or permanent station;

10 (b) Active members of the uniformed services who reside outside Oregon but paid Oregon resident
11 income taxes no later than 12 months before leaving active duty; and

12 (c) Aliens attending an Oregon school as foreign exchange students.

13 (4) A non-resident member of the uniformed services may purchase licenses, tags, and permits at resident
14 rates.

15 (5) Agents must ensure all the information to establish customer eligibility for the privilege requested is
16 submitted. If the person applying for the privilege fails to supply the necessary information, the agent may
17 not issue the requested licensing document. All daily angling licenses must show the date they become valid.

18 (6) The Department and its Agents must obtain social security numbers for any person who purchases an
19 annual, fee-based license. The Department will use this number to comply with collection of the social
20 security numbers pursuant to the child support enforcement laws as required by Section 117, Chapter 746,
21 Oregon Laws 1997. If the social security number provided by an applicant is in use by another individual, the
22 license will not be issued until the applicant provides proof that the social security number is, in fact, the
23 applicant's social security number. An official document such as a social security card, payroll document, or
24 health insurance identification card with the social security number printed on it must be presented to the
25 agent as proof. An individual's social security number is not subject to disclosure to members of the public
26 under the Oregon Public Records Law.

27 (7) License issuance is subject to terms of prior suspension or revocation per OAR 635-001-0210 and
28 OAR 635-001-0215.

29 (8) Only Department authorized documents are valid. Reproductions, receipts or other documents supplied
30 in lieu of official privilege documents are not valid and may not be issued by agents.

4 **Purpose**

5 (1) The purpose of these rules is to list definitions pursuant to hunting seasons for big game and game
6 birds.

7 (2) The documents entitled "2021 – 2022 Oregon Game Bird Regulations," and "[2021]2022 Oregon Big
8 Game Regulations", are incorporated by reference into these rules. These documents are available at hunting
9 license vendors and regional, district and headquarters offices of the Oregon Department of Fish and
10 Wildlife.

16 **Definitions**

17 (1) "Active Military Personnel" means, for the purpose of participating in the Veterans and Active
18 Military Personnel Waterfowl Hunting Day(s), members of the Armed Forces [Army, Navy, Air Force,
19 Marine Corps, and Coast Guard] on active duty, including members of the National Guard and Reserves on
20 active duty (other than for training).

21 (2) "Adult hunting license" is a resident or nonresident hunting license, resident combination angling and
22 hunting license, disabled veteran's angling and hunting license, pioneer's angling and hunting license or
23 senior citizen's angling and hunting license.

24 (3) "Agricultural lands" are lands that are not less than ten acres in extent that have been cultivated and
25 planted or irrigated to domestic crops that are currently in use. Isolated home gardens, abandoned farmsteads,
26 logged lands, rangelands, and tree farms, are not included in this definition.

27 (4) "Antler Point" is a point at least one inch in length measured from tip of point to nearest edge of beam.
28 This definition applies only to the three-point elk and spike only elk bag limits.

29 (5) "Antlerless deer" means doe or fawn deer.

30 (6) "Antlerless elk" means cow or calf elk.

31 (7) "Application" means the electronic form completed and purchased to apply for a hunt where the
32 number or distribution of hunters is limited through a public drawing or other means. Mail order applications
33 sent to the Department along with the proper remittance are used to generate the electronic form.

1 (8) "Bait" for hunting game mammals means any substance placed to attract an animal by its sense of
2 smell or taste, including but not limited to food items or minerals (such as salt). Applying a scent or attractant
3 to one's body or clothing while worn, is not baiting.

4 (9) "Baited Area" means an area where baiting has taken place.

5 (10) "Baiting" means the placing, exposing, depositing, distributing, or scattering of corn, wheat, salt or
6 other feed to constitute a lure or enticement to, on, or over an area where hunters are attempting to take game
7 birds.

8 (11) "Brace" is defined as an orthosis that is prescribed by a physician and fabricated by an orthotist
9 certified by the American Board for Certification in Orthotics and Prosthetics, Inc.

10 [~~(12) "Brace Height" is the distance from the back of the bow's riser at the handgrip to the string when the
11 bow is at rest.~~]

12 ~~(13)~~ 12 "Buck Deer" means a male deer with at least one visible antler.

13 ~~(14)~~ 13 "Buck Pronghorn" means a male pronghorn antelope with visible horns and a dark cheek patch
14 below the ear.

15 ~~(15)~~ 14 "Bull elk" for the purposes of a bag limit definition, means a male elk with at least one visible
16 antler.

17 ~~(16)~~ 15 "Calendar year" means from January 1 through December 31.

18 ~~(17)~~ 16 "Carcass" is the skinned or unskinned body, with or without entrails, of a game bird or game
19 mammal.

20 [~~(18) "Cascade elk" means any live elk occurring in the Dixon, Evans Creek, Indigo, Keno, McKenzie,
21 Metolius, Rogue, Santiam and Upper Deschutes units and those parts of Fort Rock and Sprague units west of
22 Highway 97, and that part of Grizzly Unit west of Hwy 97 and south of Hwy 26.]~~]

23 ~~(19)~~ 17 "Closed season" is any time and place when it is not authorized to take a specific species, sex or
24 size of wildlife.

25 ~~(20)~~ 18 "Coast elk" means any live elk occurring in the Alsea, Applegate, Chetco, Melrose, Powers,
26 Saddle Mountain, Scappoose, Siuslaw, Sixes, Stott Mountain, Tioga, Trask, Willamette, and Wilson units.

27 ~~(21)~~ 19 "Commercial cervid attractant" means a marketed product that contains or is derived from cervid
28 urine and is designed for use in luring, attracting or enticing a cervid.

29 ~~(22)~~ 20 "Commission" means the Oregon Fish and Wildlife Commission.

30 ~~(23)~~ 21 "Controlled hunt" is a season where the number or distribution of hunters is limited through a
31 public drawing or other means.

32 ~~(24)~~ 22 "Department" means the Oregon Department of Fish and Wildlife.

33 ~~(25)~~ 23 "Director" means the Oregon Fish and Wildlife Director.

1 (26) **24** "Doe or fawn pronghorn" means a female pronghorn antelope without a dark cheek patch below
2 the ear or a pronghorn fawn (young of the year) of either sex.

3 (27) **25** "Domestic partner" means, as provided in section 3 of the Oregon Family Fairness Act of 2007
4 (ORS Chapter 106), "an individual who has, in person, joined into a civil contract with another individual of
5 the same sex, provided that each individual is at least 18 years of age and is otherwise capable, and that at
6 least one of the individuals is a resident of Oregon."

7 (28) **26** "Eastern Oregon" means all counties east of the summit of the Cascade Range including all of
8 Klamath and Hood River counties.

9 (29) **27** "Eastern Oregon deer" means any live deer occurring east of the east boundaries of the Santiam,
10 McKenzie, Dixon, Indigo and Rogue units.

11 (30) **28** "Eligible Hunter" means someone who will be 12 years of age by the time they hunt.

12 (31) **29** "Entry permit" means a permit issued by the Department to be in an area where entry is restricted.

13 (32) **30** "Feral Swine" means animals of the genus *Sus* as defined by the Oregon Department of
14 Agriculture in OAR 603-010-0055.

15 (33) **31** "Fiscal year" means from July 1 through June 30.

16 (34) **32** "Furbearers" are beaver, bobcat, fisher, marten, mink, muskrat, otter, raccoon, red fox, and gray
17 fox.

18 (35) **33** "Game Birds" are any waterfowl, snipe, band-tailed pigeon, mourning dove, pheasant, quail,
19 partridge, grouse, or wild turkey.

20 (36) **34** "Game mammals" are pronghorn antelope, black bear, cougar, deer, elk, moose, Rocky Mountain
21 goat, bighorn sheep, and western gray squirrel.

22 (37) **35** "General season" is any season open to the holder of a valid hunting license and appropriate game
23 mammal tag without restriction as to the number of participants.

24 (38) **36** "Hunter certification" means to have met educational, safety or other requirements designated by
25 administrative rule for participation in a hunt.

26 (39) **37** "Hunt" means to take or attempt to take any wildlife by means involving the use of a weapon or
27 with the assistance of any mammal or bird.

28 (40) **38** "Husbandry" means the care given animals directly by their owners and managers, including but
29 not limited to:

30 (a) Nutrition;

31 (b) Breeding program;

32 (c) Veterinary medical care;

33 (d) Environmental cleanliness; and

34 (e) Humane handling.

1 (41) **39** "Immediate family" for the purpose of Landowner Preference, means a landowner's spouse,
2 children, sons-in law, daughters-in-law, father, mother, brother, brothers-in law, sister, sisters-in-law,
3 stepchildren, and grandchildren.; for all other purposes, it means spouse, domestic partner, children, father,
4 mother, brother, sister, stepchildren, and grandchildren.

5 (42) **40** "Inedible" means unfit for human consumption.

6 (43) **41** "Juvenile hunting license" is a resident, nonresident hunting license or resident combination
7 angling and hunting license for persons 9 to 17 years of age to hunt wildlife.

8 ~~(44)~~ **42** "Landowner", as used in OAR chapter 635, division 075, means:

9 (a) A person who holds title in trust or in fee simple to 40 or more contiguous acres of land; provided
10 however that a recorded deed or contract of ownership shall be on file in the county in which the land is
11 located; and/or

12 (b) A corporation or Limited Liability Company (LLC) holding title in fee simple to 40 or more
13 contiguous acres of land; provided however that the corporation or LLC shall be registered with the State of
14 Oregon; and/or

15 (c) A partnership holding title in fee simple to 40 or more contiguous acres of land; and/or

16 (d) Persons who hold title as part of a time share are not eligible for landowner preference.

17 (45) **43** "Low Income" means a person who is "economically disadvantaged" as defined in Section 4(8) of
18 the Federal Job Training Partnership Act of 1982.

19 (46) **44** "Mounted Wildlife" means any hide, head or whole body of wildlife prepared by a licensed
20 taxidermist for display.

21 (47) **45** "Muzzleloader" is any single-barreled (shotguns may be double barreled) long gun meant to be
22 fired from the shoulder and loaded from the muzzle with ~~[an open ignition system and]~~ open or peep sights.

23 (48) **46** "On or within" means a straight line distance measured on a map.

24 **(47) "Nonresident" means any person other than a resident.**

25 (49) **48** "One deer" means a buck, doe, or fawn deer.

26 (50) **49** "One elk" means a bull, cow, or calf elk.

27 ~~[(51) "Open Ignition" is an ignition system where the percussion cap, or frizzen, or flint is visible and
28 exposed to the weather at all times and is not capable of being closed or covered by any permanent piece of
29 the weapon.]~~

30 ~~(52) **50** "Outfitter and Guide Hunt" is an outdoor recreational activity in which the client is physically
31 accompanied in the field by the registered Outfitter and Guide or the employee(s) of the registered Outfitter
32 and Guide during the hunt.~~

33 ~~(53) **51** "Partner" means a person in an association of two or more persons formed to carry on as co-
34 owners for profit.~~

1 (54) 52 "Possession" means to have physical possession or to otherwise exercise dominion or control over
2 any wildlife or parts thereof, and any person who counsels, aids or assists another person holding such
3 wildlife is deemed equally in possession.

4 (55) 53 "Postmark" means the date of mailing as stated in a mark applied by the U.S. Postal Service to a
5 piece of mail. Office postal machine meter marks are not valid application deadline postmarks.

6 (56) 54 "Predatory animals" means coyotes, rabbits, rodents, and feral swine which are or may be
7 destructive to agricultural crops, products and activities.

8 (57) 55 "Protected wildlife" means "game mammals" as defined in OAR 635-045-0002(35) "game birds"
9 as defined in 635-045-0002(34), "furbearers" as defined in 635-045-0002(33), "threatened and endangered
10 species" as defined in 635-100-0125, and "nongame wildlife protected" as defined in 635-044-0130.

11 (58) 56 "Pursue" means the act of trailing, tracking, or chasing wildlife in an attempt to locate, capture,
12 catch, tree, or kill any game mammal, game bird, or furbearer.

13 (59) 57 "Raw pelt" means any pelt that has not been processed or converted to any usable form beyond
14 initial cleaning, stretching, and drying.

15 (60) 58 "Resident" is any person who:

16 (a) Has **physically** resided in Oregon for [~~a period of at least~~] **not less than** six consecutive months
17 immediately prior to the date of making application for a license, tag, or permit.

18 (b) Members of the uniformed services of the United States who:

19 (A) Are permanently assigned to active duty in this state, and their spouse and dependent children.

20 (B) Reside in this state while assigned to duty at any base, station, shore establishment or other facility in
21 this state.

22 (C) Reside in this state while serving as members of the crew of a ship that has an Oregon port or shore
23 establishment as its home port or permanent station.

24 **(c) [(D)]** Aliens attending school in Oregon [~~under a foreign student exchange program~~].

25 **(d) [(E)]** [~~All other persons are nonresidents~~] **Resident does not include a person:**

26 **(A) Who merely owns real property or pays property taxes in this state; or**

27 **(B) Who claims resident privileges in another state or country for any purpose.**

28 (61) 59 "River" is that portion of a natural water body lying below the level of bankfull stage. Bankfull
29 stage is the stage or elevation at which overflow of the natural banks of a stream or body of water begins to
30 inundate the upland.

31 (62) 60 "Rocky Mountain elk" is any live elk occurring east of the following described line: Beginning at
32 the California line on Highway 97; north on Highway 97 to State Highway 26 at Madras; northwest on
33 Highway 26 to east boundary of Santiam Unit; north along east boundary of Santiam Unit to the Columbia
34 River.

1 ~~(63)~~ **61** "Sabot" A carrier, bushing or device in which a projectile of a smaller caliber is centered so as to
2 permit firing the projectile within a larger caliber weapon. Cloth, paper or felt patches used with round balls
3 are not considered a sabot.

4 ~~(64)~~ **62** "Shotgun" is a smoothbore firearm, designed for firing birdshot, and intended to be fired from the
5 shoulder, with a barrel length of 18 inches or more, and with an overall length of 26 inches or more.

6 Exception: Shotguns equipped with rifled slug barrels are considered shotguns when used for hunting
7 pronghorn antelope, black bear, cougar, deer, or elk when centerfire rifles or shotguns are legal weapons.

8 ~~(65)~~ **63** "Sight bait" is exposed flesh bait within 15 feet of any foothold trap set for carnivores.

9 ~~(66)~~ **64** "Spike deer" is a deer with spike (unbranched) antlers.

10 ~~(67)~~ **65** "Spike-only bull elk" means a bull elk with at least one visible unbranched antler (a brow tine is
11 not considered an antler branch under spike-only regulations).

12 ~~(68)~~ **66** "Stockholder" is a person who owns stock within a corporation as defined in OAR 635-045-
13 0002(42)(b).

14 ~~(69)~~ **67** "Tag" is a document authorizing the taking of a designated kind of mammal at a specified time and
15 place.

16 ~~(70)~~ **68** "Take" means to kill or obtain possession or control of any wildlife.

17 ~~(71)~~ **69** "Three point plus elk" for the purposes of a bag limit definition, means a bull elk having 3 points
18 or more on one antler including the brow tine.

19 ~~(72)~~ **70** "Traditional Bow" is a long bow or recurve bow only, no compound bows are allowed during
20 "traditional" bow/archery hunts.

27 (2) Applicants shall accrue no more than one preference point per hunt number series per year.

30 to subsequent controlled hunt drawings for the respective hunt number series, except as excluded in OAR

32 (3) A preference point will automatically accrue within each controlled hunt series when an applicant's
33 first choice is selecting the preference point saver option.

1 (4) Youth nine years of age or older are eligible to apply for automatic Preference Points as described in
2 (3) provided they have a social security number, an ODFW ID number issued by the Department, and
3 purchase the appropriate (resident or nonresident) juvenile or adult hunting license.

4 (5) The Modified Preference Point System will group controlled hunt applicants by the number of
5 preference points they have accrued for each hunt number series. Applicants with the highest number of
6 preference points for each hunt number will be drawn first. Applicants having the next highest number of
7 preference points per hunt number will be drawn next. This tag issuance process will continue through
8 descending numbers of preference points until 75 percent of the tags authorized for the hunt have been
9 issued, unless all qualified applicants with preference points have been issued tags prior to that point. Any
10 tags remaining following the issuance of preference point tags will be issued through the equal-probability
11 computer drawing. Applicants unsuccessful in the preference point tag issuance procedure and those
12 applicants without preference points will be placed in the equal-probability computer drawing for the
13 remaining tags.

14 (6) Applicants, except for those with a Pioneer Combination License or a Resident Disabled Veterans
15 Combination License holder who are 65-years of age or older, successful in drawing their first choice hunt
16 except selecting the preference point saver option within a hunt number series shall have zero preference
17 points when they next apply for a tag in that hunt number series. Successful Applicants with a Pioneer
18 Combination License or Resident Disabled Veterans Combination License holders who are 65-years of age
19 or older, shall have one preference point when they next apply for a tag in that hunt number series.
20 Qualifying for both licenses will result in only one-preference point when reset.

21 (7) Beginning in 2008 applicants will not forfeit preference points accumulated for a hunt number series
22 when they do not apply for that hunt number series for two consecutive years.

23 (8) Applicants who have their hunting license suspended or revoked by legal action will forfeit all
24 preference points.

25 (9) Party applicant preference points shall be determined by totaling the preference points of all party
26 members and then calculating the average of this total. Party preference points will be rounded up from x.51
27 (e.g. 3.51 to 4, 3.50 to 3) to the next whole number.

28 (10) Department records are final to determine accrued preference points for controlled hunt applicants.

29 (11) Each applicant's preference point accrual record will be linked to [~~his or her~~]**their** permanent
30 identification number. Preference point applicants shall use the permanent identification number each time
31 they apply for a controlled hunt tag. Failure to do so shall place the applicant in the equal-probability
32 drawing for [~~his or her~~]**their** hunt number series and preference points will not be accrued together.

Mandatory Reporting Penalty

All big game tag holders, except for bighorn sheep and Rocky Mountain goat, and all turkey tag holders are required to report hunting effort and harvest.

3 State and Federal wildlife areas, refuges and special areas listed below shall be open to hunting during
4 authorized seasons, subject to the following special regulations and exceptions:

5 (1) Bear Valley National Wildlife Refuge (Klamath County): Closed to all public entry except walk-in
6 deer hunting prior to November 1.

7 (2) Cascade Head — Lincoln City Area: The Cascade Head — Lincoln City Area is closed to hunting
8 with centerfire rifles, muzzleloaders, or handguns. Hunting is restricted to archery and shotguns only during
9 authorized seasons, except for Department approved emergency hunts. Hunters using shotguns for elk shall
10 use slugs (single projectile) only. The Cascade Head — Lincoln City Area boundaries shall be defined as
11 follows: Beginning at the Pacific Ocean and Siletz River mouth, east along the north shoreline of the Siletz
12 River to Drift Cr. Rd. (mile post 1 on Hwy 229); north on Drift Cr. Rd. to Anderson Cr. Rd.; north on
13 Anderson Cr. Rd. to Schooner Cr. Rd.; west on Schooner Cr. Rd. to Forest Rd. 2200; north and east on FR

19 (3) Cold Springs Refuge (Umatilla County): The Cold Springs Refuge shall be closed to deer and elk

21 (4) Dean Creek Elk Viewing Area (Douglas County): All Bureau of Land Management lands within or
22 contiguous to BLM lands within T22S R11W (including Spruce Reach Island located adjacent to Hwy. 38
23 and between the outlets of Koapke and Hinsdale Sloughs) are closed to hunting. Also, other lands located
24 within the following boundary are closed to hunting during all elk and deer seasons that pertain to this area:

31 (6) North Bank Habitat Management Area (NBHMA; previously known as the Dunning Ranch Area in
32 Douglas County): 6,500 acres located approximately eight miles northeast of Roseburg. Area: All BLM
33 lands located in T25S, R5W, Sections 35,36; T26S, R5W, Sections 1,2,11,12,13,14; T25S, R4W, Sections
34 31,32,33; T26S, R4W, Sections 4,5,6,7,8,18. This area is closed to all big game hunting except for and

1 during controlled hunts specific to the NBHMA by hunters possessing a controlled hunt tag for the area. Elk,
2 black bear, and cougar hunting will be allowed by hunters who possess a valid NBHMA controlled hunt tag
3 in addition to valid elk, black bear, or cougar tags. The use of bait for hunting game mammals is prohibited
4 on NBHMA. All BLM lands located in T25S, R5W, Sections 35, 36; T26S, R5W, Sections 1, 2, 11, 12, 13,
5 14; T25S, R4W, Sections 31,32, 33; T26S, R4W, Sections 4, 5, 6, 7, 8, 18.

6 (7) William Finley National Wildlife Refuge (Benton County):

7 (a) Portions of the Refuge are open to deer and elk hunting under special regulations established by the
8 Refuge.

9 (b) All hunters shall obtain a refuge permit and check in and out of the refuge daily. Information about
10 deer and elk hunting locations, seasons, weapon restrictions, and application instructions are available at the
11 refuge office at 541-757-7236 or on their website (http://www.fws.gov/refuge/William_L_Finley/Hunt.html).

12 (8) Government Island State Recreation Area (Multnomah County): Use of rifles, handguns, and shotguns
13 with slugs or buckshot, and bows is prohibited at all times.

14 (9) Hart Mountain National Antelope Refuge (Lake County): Portions of the refuge shall be open for

4 (16) McKay Creek Refuge (Umatilla County): This refuge is closed to deer and elk hunting **except by**
5 **permit during controlled hunts or emergency hunts specific to the refuge.**

6 (17) Metolius Wildlife Refuge (Jefferson County): All hunting, injuring, taking, killing, or destroying any
7 wild bird or mammal on public land is prohibited on public lands within T12 and T13S, R9E, bounded by
8 USFS road 1420 and 1419 on the west; road 1400 on the south and east; and road 1420-400, Metolius River,
9 and posted boundary from the Metolius River to road 1400 on the north (approximately five square miles).
10 36 CFR 261.58(v).

11 (18) Mill Creek Watershed (Umatilla County): This watershed is closed to all access and hunting except
12 by holders of a Mill Creek Watershed controlled elk tag and a Forest Service entry permit.

13 (19) Newberry Crater Wildlife Refuge (Deschutes County): All hunting, injuring, taking, killing, or
14 destroying any wild bird or mammal is prohibited on public lands within the rim of Newberry Crater in:
15 T21S, R12E; T22S, R12E; T21S, R13E; T22S, R13E (approximately 15 square miles).

16 (20) Rimrock Springs Wildlife Area (Grizzly Unit): This area is closed to all hunting.

17 (21) Rogue River Area:

18 (a) All land within one mile of the Rogue River between Grave Creek and Lobster Creek is closed to bear
19 hunting.

20 (b) All land within 1/4 mile of the Rogue River in the wild river section from Grave Creek downstream to
21 Watson Creek is closed to all hunting except during authorized seasons.

22 (22) Snake River Islands (Malheur County): Closed to hunting with rifles.

23 (23) South Slough National Estuarine Reserve: Specific areas are closed to hunting due to public health
24 and safety. Contact reserve headquarters office for specific closures.

25 (24) Starkey Experimental Forest Enclosure (Union County): That portion of The Starkey Experimental
26 Forest within the eight foot high elk-proof fence enclosure is closed to all hunting during deer and elk season
27 except for persons possessing a controlled hunt tag for the area. A posted 1/4 mile buffer zone on the
28 National Forest lands surrounding the enclosure is closed to all hunting with a centerfire rifle or bow. The
29 enclosure is open to deer and elk hunting only by permit during controlled hunts. The main study area is
30 open to hunting of other species during authorized seasons. The 12-foot right-of-way along each side of all
31 eight foot-high perimeter and internal game fences is closed to all motorized travel. Public entry is allowed
32 only through the main gate. The Experimental Forest is closed to all public entry during the winter closure,

34 1] annually. Access and Habitat auction or raffle tag holders, Mandatory Incentive Tag holders, and

Premium Deer and Premium Elk tag holders are not eligible to hunt in the Starkey Experimental Forest enclosure.

(25) Umatilla Refuge (Morrow County): This refuge is closed to deer and elk hunting except during controlled hunts specific to the refuge and emergency hunts as provided in OAR chapter 635, division 078.

(26) Willamette River Greenway Corridor: Hunting is permitted with shotguns or bows and arrows only during authorized season on Willamette River Greenway parcels, except in those parcels where hunting is prohibited.

Hunting Prohibited

It is unlawful:

(1) To hunt with a centerfire rifle during the deer and elk seasons and dates in the Wildlife Management Units listed in Table 1 below without a used or unused deer, elk, pronghorn, antelope, bighorn sheep, or Rocky Mountain goat tag valid for the dates and area being hunted.

(2) To hunt on any refuge closed by the state or federal government.

1 (4) Notwithstanding section (3) of this rule, controlled antlerless elk hunts are permitted within the south
2 city limits of Seaside if the herd should become a serious problem.

3 (5) To hunt in any Safety Zones created and posted by the Department.

4 (6) To hunt protected wildlife except:

5 (a) By a permit or during an authorized season established by the commission.

12 computer-assisted hunting in Oregon. As used in this act, "computer-assisted hunting" (Internet hunting)
13 means the use of a computer or any other device, equipment, or software to remotely control the aiming and
14 discharge of a firearm, bow, or any other weapon to hunt any game bird, wildlife, game mammal, or other
15 mammal, and "facilities for computer-assisted remote hunting" means real property and improvements on the
16 property associated with hunting, including hunting blinds, offices and rooms equipped to facilitate
17 computer-assisted remote hunting. Nothing in subsection (8) of this section prohibits the use of computer-

25 It is unlawful:

26 (1) To take or hold in captivity the young of any game mammal.

27 (2) To hold in captivity any wildlife of this state for which a permit is required without first securing a
28 permit.

29 (3) To release without a permit any wildlife brought from another state or country, or raised in captivity in
30 this state.

31 (4) To resist game law enforcement officers.

32 (5) To refuse inspection of any license, tag or permit, and any wildlife taken, by an employee of the
33 Department; any person authorized to enforce the wildlife laws; or a landowner or agent of the landowner on
34 his or her land while on that property.

1 (6) To refuse inspection, by an employee of the Oregon Department of Fish and Wildlife, or any person
2 authorized to enforce wildlife laws, of any gear used for the purpose of taking wildlife.

3 (7) To take or attempt to take any game mammals, game birds, migratory waterfowl or any protected
4 wildlife species of any size or sex or amount, by any method or weapon, during any time or in any area not
5 prescribed in these rules.

6 (8) To disturb, damage, remove, alter or possess any official Department signs.

7 (9) To sell, lend, or borrow any big game tag.

8 (10) It is unlawful to operate or to be transported in a motor-propelled vehicle in violation of Cooperative
9 Travel Management Areas. "Motor-propelled vehicle" includes aircraft not landing on designated airstrips.
10 Through cooperative agreement, motor vehicle use is limited to specific roads during the dates for the areas
11 listed below.

12 There are two methods of posting road access information; negative marking in which closed roads are
13 marked by signs, gates, berms, or other similar indicators, or positive marking in which open roads are

32 (1) To take or hold in captivity the young of any game mammal.

33 (2) To hold in captivity any wildlife of this state for which a permit is required without first securing a
34 permit.

1 (3) To release without a permit any wildlife brought from another state or country, or raised in captivity in
2 this state.

3 (4) To resist game law enforcement officers.

4 (5) To refuse inspection of any license, tag or permit, and any wildlife taken, by an employee of the
5 Department; any person authorized to enforce the wildlife laws; or a landowner or agent of the landowner on
6 his or her land while on that property.

7 (6) To refuse inspection, by an employee of the Oregon Department of Fish and Wildlife, or any person
8 authorized to enforce wildlife laws, of any gear used for the purpose of taking wildlife.

9 (7) To take or attempt to take any game mammals, game birds, migratory waterfowl or any protected
10 wildlife species of any size or sex or amount, by any method or weapon, during any time or in any area not
11 prescribed in these rules.

12 (8) To disturb, damage, remove, alter or possess any official Department signs.

13 (9) To sell, lend, or borrow any big game tag.

14 (10) It is unlawful to operate or to be transported in a motor-propelled vehicle in violation of Cooperative
15 Travel Management Areas. "Motor-propelled vehicle" includes aircraft not landing on designated airstrips.
16 Through cooperative agreement, motor vehicle use is limited to specific roads during the dates for the areas
17 listed below.

24 **Purpose and General Information**

25 (1) The purpose of these rules is to establish season dates, bag limits, areas and other restrictions for bow
26 and muzzleloader hunting, Premium Hunts, and controlled deer and elk youth hunts; pursuant to ORS
27 Chapter 496.

28 (2) Controlled hunt tag numbers for [2021]2022 for Premium Hunts, deer and elk bow and muzzleloader
29 hunting and deer and elk youth hunts are listed in the “[2021]2022 Oregon Big Game Regulations” and are
30 adopted and incorporated into OAR chapter 635, division 073 by reference.

31 (3) OAR chapter 073 incorporates, by reference, the requirements for bow and muzzleloader hunting,
32 Premium Hunts, and controlled deer and elk youth hunts set out in the document entitled
33 “[2021]2022 Oregon Big Game Regulations,” into Oregon Administrative Rules. Therefore, persons must
34 consult the “[2021]2022 Oregon Big Game Regulations,” in addition to OAR chapter 635, to determine all

1 applicable requirements for bow and muzzleloader hunting, Premium Hunts, and controlled deer and elk

14 **Landowner Hunting Preference Tags in Special Seasons**

15 (1)(a) Landowner hunting preference tags are not available for Premium Hunts (series L, M, and N) or the
16 long duration youth elk hunts (August 1 - December 31) or the Melrose 223T (August 1 - March 31) youth
17 elk hunt.

18 (b) During controlled elk hunts with a bag limit of spike or better in units where the usual bag limit for
19 bull elk is spike only, landowner hunting preference tags may be limited to five tags or 10 percent of the total
20 controlled hunt tags whichever is greater; the bag limit for these elk tags shall be spike or better.

21 (c) In the following hunts LOP tags will be limited to five tags or 10% of the total controlled hunt tags,
22 whichever is greater: elk hunts; 252A1, 254R1, 254Y1, 255R1, 255Y1, 256R1 and 256Y1: buck deer hunts;
23 141C, 142B, 143C, 145A, 148A, 154C, 157A, [~~165R~~], and [~~170R3~~]**165R2**.

24 (2) If landowner preference tags remain from the controlled hunts described in 635-075-0020(1)(b) after
25 the game mammal controlled hunt drawing, the Department will issue remaining tags to qualified landowners
26 as described in 635-075-0024.

31 **Landowner Hunting Preference Tags for Mule Deer**

32 (1) This rule further implements HB 2027A whereby the 2013 Legislative Assembly directed the
33 Department through the commission to specify a formula that bases the number of landowner preference tags

1 available for mule deer on the management, research, and habitat needs set forth in the wildlife management
2 plan for mule deer.

3 (2) For purposes of this rule, the population management objectives (MOs) for each wildlife management
4 unit that were adopted by the commission in August 2016 are considered representative of the management,
5 research, and habitat needs for mule deer.

6 (3) The formula to determine the number of landowner hunting preference tags available for buck deer in a
7 unit is as follows:

8 (a) In those wildlife management units where the estimated mule deer population is less than 60% of the
9 established population management objective, the number of landowner hunting preference tags available for
10 buck deer in that unit may be limited to five tags or 10 percent of the total controlled buck tags authorized for
11 the public for each hunt in that unit by the commission, whichever is greater.

12 (b) In those wildlife management units where the estimated mule deer population is equal to or more than
13 60% of the established population management objective, but less than 80% of the established population
14 management objective, the number of landowner hunting preference tags available for buck deer in that unit
15 may be limited to five tags or 15 percent of the total controlled buck tags authorized for the public for each
16 hunt in that unit by the commission, whichever is greater.

17 (c) In the Biggs, Columbia Basin, and Mount Emily wildlife management units, and in the NE Owyhee
18 167A hunt area, and in those wildlife management units where the estimated mule deer population is equal to
19 or more than 80% of the established population management objective, the number of landowner hunting
20 preference tags available for buck deer in that unit may be issued based upon a landowner's acreage as set
21 forth in 635-075-0005(8).

22 (d) If conditions such as but not limited to disease or harsh winter weather occur, resulting in adoption of
23 a Temporary OAR to reduce 100 Series mule deer tags by equal to or more than 25% from the number
24 authorized by the Commission in areas listed or described in 635-075-0022(3)(c), Limited Landowner
25 Preference mule deer tags in those areas may be limited as described in 635-075-0022(3)(b).

26 (4) If landowner preference tags remain from the controlled hunts described in 635-075-0022(3)(a) or (b)
27 after the game mammal controlled hunt drawing, the Department will issue remaining tags to qualified
28 landowners as described in 635-075-0024.

29 (5) Landowner Hunting Preference Tag numbers for mule deer in [2021] **2022** will be adopted by
30 temporary rule prior to the June [2021] **2022** controlled hunt draw.
