Attachment 3_Draft Memorandum of Agreement_Cow Creek_ODFW_11- 30-22	5	<p>Text edits to section 2 to clarify that this agreement does not relate to CCBUTI's rights.</p> <p>This Agreement does not define the specific extent of such rights possessed <u>harvest</u> by the Cow Creek Band of Umpqua Tribe of Indians, nor the specific amount or number of fish and wildlife resources that may be harvested by the Tribe's members at any particular time. Instead, this Agreement provides agreed-upon standards for the Tribe to exercise such harvest rights and to determine tribal harvest levels in cooperation with ODFW.</p>
Attachment 3_Draft Memorandum of Agreement_Cow Creek_ODFW_11- 30-22	9	<p>Adds description to the geographic principles that is comparable to other MOAs between the state and a tribe.</p> <p>a. General Principles. This Agreement is limited to the geographic area described in 5(b), <u>including but not limited to discrete watersheds, habitats or ecosystems, or ODFW Wildlife Management Units within the boundaries of Oregon where the Cow Creek Band of Umpqua Tribe of Indians has a modern, historic or ancestral interest.</u></p>

Attachment 3_Draft Memorandum of Agreement_Cow Creek_ODFW_11- 30-22	25	Adds an OAR to this appendix that was missed in drafting the agreement. <u>Dunes National Recreational Area 635-065-0625(5) and 635-050-0210(33)</u> Use of rifles and handguns is prohibited for all hunting in that portion of the Siuslaw Unit west of Highway 101 and north of Tahkenitch Creek. <u>Oregon Dunes National Recreation Area is open to hunting as permitted by the Department but closed to trapping furbearing and unprotected mammals.</u>
