Dear Chair Wahl and Commissioners,

The 30 undersigned organizations are writing in support of the Petition to List Southern Resident Orcas (*Orcinus Orca*) as an Endangered Species Under the Oregon Endangered Species Act and urge the Commission to accept the petition and advance rulemaking.

The Southern Resident orcas are a well-known and beloved species worldwide. They are also highly endangered. Their population has not made progress towards recovery since being listed under the federal Endangered Species Act in 2005. Threats to the orcas remain prevalent and persistent throughout their range, and collaborative action among Northwest decision-makers is urgently needed to address them. Recovery efforts must occur at all levels – federal, state, and local – and Oregon has an opportunity to contribute to the actions needed to ensure a future for these magnificent icons of the Pacific Northwest.

Human-induced changes to the ecosystem that the Southern Residents rely on and decline of their primary food, Chinook salmon, have driven the population's decrease regionwide. Urban, agricultural, and industrial growth has altered the river systems that support salmon and introduced long-lasting, toxic pollutants to their waters. Increasingly busy and noisy oceans make it harder for the orcas to find already-scarce food, and a single catastrophic event, such as an oil spill, could wipe out their population entirely.

For too long, Oregon has deferred responsibility for Southern Resident orca recovery to Washington or to the federal government. Listing the Southern Residents as endangered will signal that Oregon is ready to do its part in addressing the myriad threats humans continue to pose to their survival. It will enable a range of conservation measures, catalyze coordination among state and federal agencies, streamline and complement Oregon's work to recover wild salmon, and advance additional actions to support ecosystem restoration and resiliency for the Southern Residents.

Oregon's waters are a fundamental part of the Southern Residents' home range. They regularly forage off the Oregon coast in the late winter and early spring, targeting Chinook salmon as they return to the Columbia River watershed and coastal rivers. They rely on migration corridors off Oregon to travel to their southernmost feeding grounds in Monterey Bay, California, and back to their core summer habitat in the Salish Sea. Oregon is part of their home, and it is past time to recognize them as Oregon's orcas too.

The Southern Resident orcas are out of time. Their population is on the brink of collapse, and they need every advantage we can give them. They need Oregon to be a champion. We urge the Commission to accept this petition to demonstrate the state's commitment to recovering these iconic orcas.
