**Subject: Please protect SRKW orcas
under the Endangered Species Act**

Commission Oregon DFW,

I write in strong support of listing Southern Resident orcas as an endangered species under the Oregon Endangered Species Act (OESA). In recognition of this orca's endangered status, their presence in Oregon's coastal waters, dependence on Oregon's resources, and their profound cultural significance to peoples across the Pacific Northwest, please vote to adopt this listing.

The Southern Resident orcas urgently need our help. Human impacts on their population, their ecosystem and, most critically, their prey have driven these magnificent animals to the brink of extinction. The decline of their primary food source, Chinook salmon, have left the orcas starving and weak.

We all vividly remember when the grieving orca mother Tahlequah carried her stillborn calf for 17 days in 2018, demonstrating this cruel reality to the world. And just last week, the newest Southern Resident calf (J60) was presumed dead. With less body fat to absorb toxic pollutants in the water, these orcas are more vulnerable to sickness.

Our increasingly busy and noisy oceans also make it harder for the orcas to find already-scarce food, and a single catastrophic event, such as an oil spill, could wipe out their population entirely.







Oregon plays a vital role in the Southern Residents' survival. The orcas forage for salmon off the Oregon coast in late winter and early spring, and they spend summers feeding near the mouth of the Columbia River. Columbia River Basin (CRB) Chinook salmon account for more than half of the Chinook consumed by the orcas while they're in coastal waters.

The most impactful thing Oregon can do for the Southern Residents is to restore wild Chinook salmon, their preferred prey. The state has already shown admirable leadership by taking bold steps to remove the Klamath River dams and advocating for comprehensive solutions to restore CRB Chinook salmon, but the benefits of these actions will take time to mature, and the Southern Residents cannot wait. We encourage the state to leverage this listing to achieve further progress in restoring Chinook salmon populations.





The federal Endangered Species Act has played an important role in combating the decline of the Southern Residents. Despite all of our efforts, however, their population continues to decline. In 2007, they numbered 87 individuals. Today with the presumed death of J60 they number 74, and we are at risk of losing this unique and iconic species forever.







We urge the Commission to grant the Southern Resident orcas the protections they need. Listing the Southern Residents will catalyze coordination among state and federal agencies, streamline and complement Oregon's work to recover wild salmon, and advance additional actions to support ecosystem restoration and resiliency for the Southern Residents. Above all, it will demonstrate Oregon's commitment to recovering the beloved orcas that have lived and foraged off Oregon's coast since time immemorial – long before humans ever arrived.




