### HUNT SAFELY – HUNT RESPONSIBLY

**Every hunter has the responsibility to enter the field well prepared to hunt in a safe, ethical manner; the future of our hunting heritage depends on it.**

#### The Four Primary Rules of Firearm Safety

1. **Muzzle** – Control the direction of your muzzle at all times.
2. **Trigger** – Keep your finger outside of the trigger guard until ready to shoot.
3. **Action** – Treat every firearm as though it were loaded – Open the action and visually check if it is loaded. Firearms should be unloaded with actions open when not actually in use.
4. **Target** – Be sure of your target, and what is in front of it and beyond it.
