Compact Action

The Columbia River Compact agencies of Oregon and Washington met today and took the following actions:

Non-Indian Fisheries

Late Fall Commercial Salmon Fishery

- Adopted non-Indian commercial fishing periods as follows:

Season:	7 PM Wednesday September 30 to 7 AM Thursday October 1, 2009	(12 hrs)
	7 PM Thursday October 1 to 7 AM Friday October 2, 2009	(12 hrs)
	7 PM Sunday October 4 to 7 AM Monday October 5, 2009	(12 hrs)
Area:	(Zones 4-5).	
Gear:	8" minimum and 9¾" maximum mesh size restrictions.	

Season:	7 AM through 7 PM Monday October 5, 2009	(12 hrs)
Area:	(Zones 1-3).	
Gear:	6" maximum mesh size restriction, un-slackened floater gillnet.	

- The following Allowable Sales, Miscellaneous Regulations, Sanctuaries, and Washington Reporting Rule apply to all non-Indian commercial salmon seasons adopted above:

Allowable Sales: Salmon and white sturgeon. A maximum of **five** white sturgeon may be possessed or sold by each participating vessel during each calendar week (Sunday through Saturday) of the open fishing periods. The **five** white sturgeon possession and sales limit includes mainstem fisheries **only**. Select Areas remain closed to white sturgeon retention.

Miscellaneous Regulations: **Multiple Net Rule:** Nets not specifically authorized for use in this fishery may be onboard the vessel if properly stored. A properly stored net is defined as a net on a drum that is fully covered by a tarp (canvas or plastic) and bound with a minimum of ten revolutions of rope with a diameter of 3/8 (0.375) inches or greater.

Sanctuaries: As applicable: Elokom-B, Abernathy, Cowlitz, Kalama-B, Lewis-B, Sandy and Washougal River sanctuaries are in effect.

Washington Reporting Rule: WDFW adopted a regulation requiring all Washington wholesale buyers purchasing fish from commercial fisheries to send a report of their landings to WDFW within 24 hours of the closure of the fishery via either:

The following fisheries were modified by Compact action in concurrent OR/WA jurisdiction waters and by the state of Oregon or Washington in state waters.

Deep River Fishery (Zone 80)

- Effective Wednesday September 30, 2009 the open hours for the Deep River Select Area Commercial Fishery are 4 PM to 9 AM on Monday, Tuesday, Wednesday, and Thursday nights through October 30, 2009.
- All other area, gear, allowable sales, and reporting regulations adopted previously remain unchanged.

FUTURE MEETINGS

- A compact hearing is scheduled for 3 PM Tuesday October 6, 2009 via teleconference to review salmon stock status and ongoing fisheries.
