Compact Action

The Columbia River Compact agencies of Oregon and Washington met today and took the following actions:

Select Area Fisheries

- The following fisheries were considered by the Columbia River Compact in concurrent OR/WA jurisdiction waters and by the state of Oregon or Washington in state waters.

Youngs Bay Commercial Salmon Fishery (Zone 7)

- Adopted the following winter season periods:

Youngs Bay	5 PM – 9 PM Thursday March 29	(4 hours)
(Entire Area)	8:30 AM – 12:30 PM Tuesday April 3	(4 hours)

Youngs Bay	10 AM – 2 PM Thursday April 5	(4 hours)
(Walluski Area)	2 PM – 6 PM Monday April 9	(4 hours)

Walluski Area: Open area is Youngs Bay/River upstream of the overhead powerlines located approximately 500 yards northwesterly (downstream) of the Walluski River mouth, the Walluski River downstream of the Highway 202 Bridge, and the Youngs River downstream of the regulatory markers at the confluence of the Klaskanine and Youngs rivers.

Tongue Point/South Channel Commercial Salmon Fishery (Zone 71)

- Adopted the following winter season periods:

South Channel	7 PM – 11 PM Thursday March 29	(4 hours)
only	10 PM Monday April 2 – 2 AM Tuesday April 3	(4 hours)
	11:30 PM Thursday April 5 – 3:30 AM Friday April 6	(4 hours)
	4 AM – 8 AM Tuesday April 10	(4 hours)

Blind Slough (Zone 74) and Knappa Slough (Zone 73) Commercial Salmon Fishery

- Modified the hours for the previously adopted winter season periods. Modifications in **bold**.

Blind Slough	7 PM Thursday March 29 – 7 AM Friday March 30	(12 hours)
and Knappa Slough	7 PM Monday April 2 – 7 AM Tuesday April 3	(12 hours)

- Adopted the following winter season periods:

Blind Slough	7 PM Thursday April 5 – 7 AM Friday April 6	(12 hours)
only	7 PM Monday April 9 – 7 AM Tuesday April 10	(12 hours)

- All other regulations previously adopted on January 30, 2018 remain in effect.
- Permanent regulations including rules related to transportation and lighted buoys remain in effect.

- No hearings are scheduled at this time. The Joint Staff will recommend additional hearings as needed.
