

**TRIBAL STAFF REPORT
SUMMER FACT SHEET No. 2
Columbia River Compact
June 23, 2006**

Purpose: To consider treaty Indian commercial fishing options for the mainstem Columbia River.

Treaty Indian Summer Season Fisheries

Currently the platform/hook and line fishery is open for sales and subsistence use in all of Zone 6. Sales of platform caught fish began on June 8. The platform expects to harvest about 1,000 summer Chinook and 1,000 sockeye over the summer management period (through July 31 assuming the platform fishery continues through the end of July). The summer season catch projections will be adjusted based on future catch updates.

Based on this week's fishery and recent summer season fisheries, the expected gillnet catch is about 2,600 Chinook and 150 sockeye per weekly opening. With the estimated platform catch through July 31 and no additional gillnet fishing, the total Chinook harvest would be 8,818(18.0%). The sockeye harvest would be 1,434(4.6%).

Treaty Indian Commercial Fishery Proposal

<i>Recommendation</i>	
	Commercial Gillnet Fishery (2.5 days per week)
Dates:	6:00 AM ___day, June __ until 6:00 PM ___day, June __ 6:00 AM Wednesday, July 5 until 6:00 PM Friday, July 8.
Area:	All of Zone 6
Gear:	7 inch minimum mesh size restriction
Sanctuaries:	Standard river mouth and dam sanctuaries remain in effect. The Spring Creek Hatchery Sanctuary is not necessary this time of year.
Allowable Sales:	Chinook, coho, steelhead, walleye, carp, and shad may be sold or retained for subsistence. Sockeye may not be sold but may be retained for subsistence. Sturgeon may not be sold. Sturgeon between 4-5 feet in length in The Dalles and John Day pools may be retained for subsistence. Sturgeon between 45-60 inches in the Bonneville pool may also be retained for subsistence.
Miscellaneous Rules:	The quick reporting rule for Washington buyers will be in effect.

- The tribes propose continuation of commercial sales of platform and hook and line caught fish that began on June 8 until further notice. The allowed sales would include Chinook, coho, steelhead, walleye, carp, and shad may be sold or retained for subsistence. Sockeye may not be sold, but may be retained for subsistence. Sturgeon may not be sold. Sturgeon between 4-5 feet in length in The Dalles and John Day pools may be retained for subsistence. Sturgeon between 45-60 inches in the Bonneville pool may also be retained for subsistence. No Compact action is required.
- The Yakama Nation will continue to allow commercial sale of fish caught in their Zone 6 tributary fisheries that overlap with commercial Zone 6 periods. Sales were allowed beginning June 8 and will continue until further notice. No Compact Action is required for the ongoing tributary sales. The general fishing schedule for these tributaries is:
