Columbia River Compact
October 19, 2009**

***Fisheries Under Consideration:* Non-Treaty Commercial Salmon**

Management guidelines, allocations, and run forecasts for the 2009 fall season were presented in Fall Fact Sheets #1(July 29, 2009) and # 11 (September 22, 2009)

- Coho passage at Bonneville Dam through October 18 totals 196,300 adults, compared to the preseason expectation of 160,100 adults. Passage is typically 92% by October 18.
- Coho returns to lower river facilities have generally been meeting or exceeding expectations. Tributary dam counts have been strong and some hatcheries are reporting very good returns to date. Some lower river hatcheries are not observing the returns expected to date, likely due to lack of rain until recently which should trigger migration into the facilities.
- TAC reviewed early and late coho stock status this morning (October 19) and reported that overall the run was tracking at or slightly ahead of expectations. TAC observed that the early stock return appears to be tracking slightly less than the preseason forecast of 466,700 fish, and that the late stock return appears to currently be tracking ahead of the preseason forecast of 236,600 fish. TAC indicated that hatchery return data is the limiting factor in providing a point estimate for an in season runsize update.

- Based on inseason run estimates, updated ocean FRAM models, and projected landings, staff estimates 400 white sturgeon and 7,000 coho are available for harvest.

Allowable Sales:	Salmon and white sturgeon. A maximum of 7 white sturgeon may be possessed or sold by each participating vessel during each calendar week (Sunday through Saturday) that the fishery is open. Limit applies to mainstem only. Select Areas remain closed to white sturgeon retention.	
Sanctuaries:	As applicable: Elokomina-A, Cowlitz, Kalama-A, Lewis-A, Sandy, and Washougal rivers.	
Additional Rules	24-hour Quick Reporting Rules will be in effect for Washington buyers. Nets not specifically authorized for use in this fishery may be onboard the vessel if properly stored. A properly stored net is defined as a net on a drum that is fully covered by a tarp (canvas or plastic) and bound with a minimum of ten revolutions of rope with a diameter of 3/8 (0.375) inches or greater.	

- ✓ Estimated catch for Season #1 include 500 Chinook, 200 coho and 150 white sturgeon. Catch estimates for season #2 include 100 Chinook, 3,000-5,000 coho and 50 white sturgeon.
- ✓ Combined impacts (including the proposed fisheries) total approximately 19.5-19.7% for lower Columbia River coho (compared to the 20% limit). Impacts to ESA listed Chinook, steelhead, and chum are expected to remain well within the allowed limits.
- ✓ Based on declining effort and catch in the Zone 4-5 fisheries, staff will likely not recommend additional fisheries beyond those proposed today.
