NEW SECTION

WAC 220-20-01000F General provisions—Lawful and unlawful acts.

Notwithstanding the provisions of WAC 220-20-010, effective immediately until further notice, it is unlawful for any person who loses or abandons commercial net fishing gear (e.g. trawl, gill, seine, lampara, reef) within the waters of the state to fail to:

(1) Contact the Department of Fish and Wildlife within 24 hours of the loss by phone at 855-542-3935 or online at <http://wdfw.wa.gov/fishing/derelect/>; and

(2) Provide the following required information:

- Type of gear
- General location
- Latitude (if known)
- Longitude (if known)
- Estimated water depth
- Date lost
- Time lost
- Name
- Telephone number
- E-mail address (if available)

(3) Failing to report lost or abandoned commercial net gear is punished as an infraction under RCW 77.15.160.
