Seller Instructions

- Page 1 is completed and signed by all owners listed on the permit(s)
- Permit Release Statement (Page 3) is signed in section 1 by all owners listed on vessel title
- Permit Release Statement (Page 3) is signed in section 2a by either the vessel owner(s) if there is no contract, lien, encumbrance or other security hold on the vessel, **OR** in section 2b by the security interest holder

Purchaser Instructions

- Copy of Current Boat Documentation or Registration is enclosed for all vessels
- Page 2 is completed and signed by the person(s) purchasing the permit(s)
- Please fill out the included application if you need to purchase permit, and/or if needed, boat license

Instructions for Ownership Change (permit(s) not leaving vessel)

- Page 2 is completed by Vessel & permit(s) purchaser(s)
- Bill of Sale (Page 4) is completed and signed by all owners listed on vessel permit(s)

Sea Urchin Permit Transfer Instructions

- Page 1 & bill of sale (Page 4) are completed by permit seller
- Page 2 is completed by permit purchaser, and purchaser has also purchased an individual personal commercial license
- Individual purchasing permit has an individual license, or application and fees are enclosed to purchase license. (\$102.00 for resident \$152.00 for non-resident)

Note: If corporations or LLC are involved, articles of incorporation are needed, showing authorization of person signing.

Note: Crab and Shrimp Permits are measured by overall length only. A survey is required on all vessels involved.

**Oregon Administrative Rule 635-005-0480
Dungeness Crab Buoy Tag and Gear Marking Requirements**

It is unlawful for commercial purposes to:

(1) Use commercial Dungeness crab gear in the Columbia River or Pacific Ocean unless the gear is individually marked with a surface buoy bearing, in a visible, legible and permanent manner, the buoy brand and buoy color(s) of the owner, and the Department buoy tag, provided that:

(a) The buoy brand consists of letters and/or numbers, and the buoy brand and buoy color or color combination are registered with and approved by the Department; The buoy color or color combination shall be submitted to the Department as a color photograph for registration;

(b) Only one unique buoy brand and one buoy color or color combination shall be registered to any one permitted vessel;

(c) All Dungeness crab gear fished by a permitted vessel must use only the Oregon buoy brand number and at least one buoy with the buoy color or color combination registered to that vessel in the area off of Oregon;
