- Copy of Current Boat Documentation or Registration is enclosed for all vessels.
- Page 1 is completed and signed by all owners listed on the permit(s)
- Permit Release Statement (page 3) is signed in section 1 by all owners listed on vessel title
- Permit Release Statement (page 3) is signed in section 2a by either the vessel owner(s) if there is no contract, lien, encumbrance or other security hold on the vessel, **OR** in section 2b by the security interest holder
- Current Vessel permit card is attached to page 1, or Certification of lost or destroyed permit form (page 5) is completed

***Purchaser Instructions***

(b) Authority to use branded gear by other than the hired captain fishing from the owner's boat shall be in writing by the pot owner, with the document to be available for inspection on demand by persons authorized to enforce the commercial fishing laws of this state.
