Open Area: Any area within Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures as defined in OAR Chapter 635, Division 065)  
Weapon: Any weapon legal for elk and deer hunting  
Number of tags: The successful bidder will receive one (1) deer and one (1) elk

## Four (4) A&H Statewide Deer Hunts

Bag limit: One (1) deer  
Season: August 1, 2027 – November 30, 2027  
Open Area: Any area within Oregon wildlife unit boundaries as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065)  
Weapon: Any weapon legal for deer hunting  
Number of tags: Each successful bidder will receive one (1) deer

Number of tags: Each successful bidder will receive one (1) elk

Open Area:	Any area open to controlled buck deer rifle hunts within the following units: 46, 65-72, 74; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065)
Weapon:	Any weapon legal for deer hunting
Number of tags:	One (1)

### **A&H Central Oregon Deer Hunt**

Bag limit: One (1) deer  
Season: August 1, 2027 – November 30, 2027  
Open Area: Any area open to controlled buck deer rifle hunts within the following units: 31-43, 73, 75-77; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065)  
Weapon: Any weapon legal for deer hunting  
Number of tags: One (1)

### **A&H Northeast Oregon Elk Hunt**

Bag limit: One (1) elk  
Season: August 1, 2027 – November 30, 2027  
Open Area: Any area open to controlled elk rifle hunts within the following units: 44, 45, 47-64; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065)  
Weapon: Any weapon legal for elk hunting  
Number of tags: One (1)

### **A&H Central/Southeast Elk Hunt**

Bag limit: One (1) elk  
Season: August 1, 2027 – November 30, 2027  
Open Area: Any area open to controlled elk rifle hunts within the following units: 31-43, 46, 65-77; as defined in OAR Chapter 635, Division 080 (except federal refuges and specific area closures defined in OAR Chapter 635, Division 065)  
Weapon: Any weapon legal for elk hunting  
Number of tags: One (1)

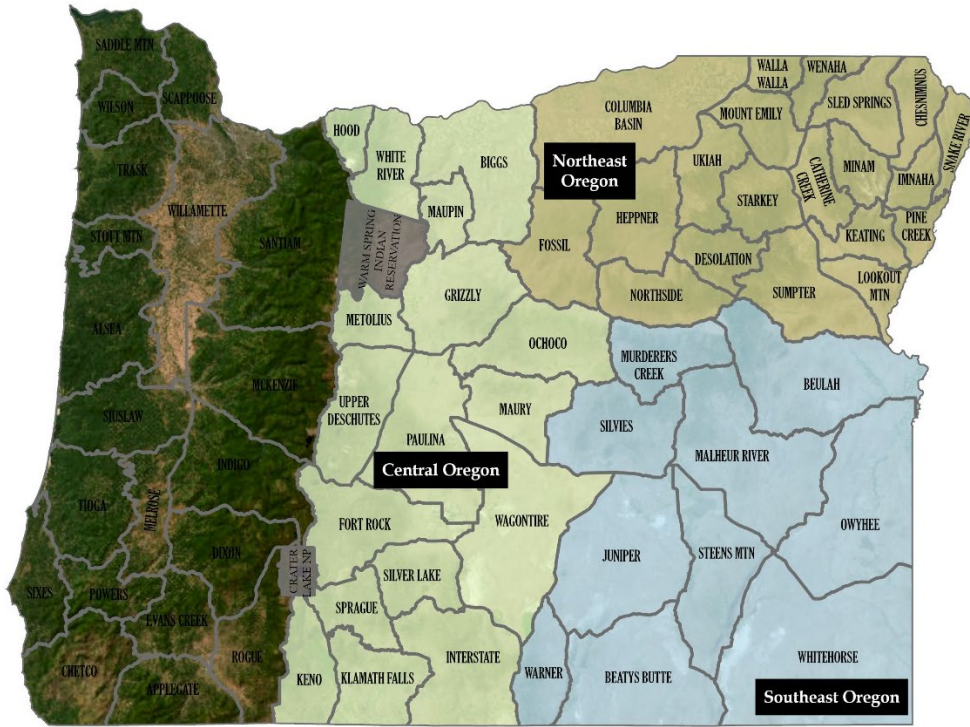
### **A&H Western Oregon Elk Hunt**

Weapon: Any weapon legal for elk hunting  
Number of tags: One (1)
