11. Briefly explain what the project proposes to do:

[This project proposes to continue to pay Dustin and Amelia Haguewood \\$2.10/acre for year-round "Welcome to Hunt" hunting access on 3,035 acres of private land in the Columbia Basin Wildlife Management Unit \(WMU\) for a period of 5 years \(2026-2030\) to hunt big game, upland game birds, small game and predators.](#)

12. Habitat and Landscape: Describe the habitat and landscape of the project area.

[This portion of the Social Ridge Access Area is a working wheat farm that currently encompasses 3,035 acres near the town of Heppner, OR. The area provides critical winter range](#)

for mule deer, along with valuable summer and transitional habitat. In addition to big game, Social Ridge supports a diverse range of upland bird species, including pheasant, quail, and mourning dove. Pronghorn antelope and a variety of nongame species reside in the area. ODFW (the Department) collaborates closely with landowners and the local Soil and Water Conservation District (SWCD) to maintain and enhance wildlife habitat.

13. **Background:** Describe the project area and explain the wildlife habitat and/or access challenge or opportunity this project will address. Address how current management actions benefit public access and/or wildlife, and their habitat needs.

Access- In an area that has experienced significant declines in public access in recent years, the Social Ridge Access Area continues to offer 3,035 acres of "Welcome to Hunt" hunting access for big game, upland game birds, small game and predators. This property is heavily utilized by the hunting public and supports the highest deer hunter densities within the NB 02 Deer Hunt Area. Additionally, the access area receives some of the highest upland bird hunter use in the Heppner Area. In a hunt area that has 0% public lands, the Social Ridge Access Area continues to attract and accommodate a diverse range of users.

14. **Past A&H History:** Describe any past Access & Habitat project, especially if the proposed project deals with continuation or amendment to a past project.

The property is a working wheat farm northwest of Heppner, OR. Comprised of rangelands and row crop production, the access area provides habitat for mule deer, pheasant, quail, Hungarian partridge, chukar, small game and predators. ODFW (the Department) does not pay access payments for wheat fields in the years that they are fallowed, as they do not provide wildlife habitat. Therefore, the Department only pays for half of the wheat acres per year.

15. **Hunter Use Data:** New Projects: Must give estimates of expected usage and how usage will be assessed. Old Projects: Use Access Area Permit data, vehicle or pedestrian counts, hunter interviews, etc.

Hunter access has been provided in accordance with the agreement for the 2020-2025 hunting seasons. Hunter use is forecasted to remain high as the access area falls within the NB-02 Deer Hunt Area, which is 0% public lands. The access area continues to provide valuable access for public hunters who would otherwise have a difficult time finding opportunities.

Hunter use is tracked through the collection of access area permits. The access area averaged 102 hunters per hunting season (big game/upland game bird) from 2020-2025. The Department feels that these figures are low based on the fact that there is only one entry point kiosk for all of Social Ridge and not all hunters submit permits. Staff also believe that some hunters will sign in once, but will utilize the property for multiple days. Non-hunting recreational use, such as wildlife viewing, has also remained constant. Overall, the property continues to be well utilized throughout the year by a diverse range of user groups.

16. **Project Objective(s):**

(a) What is the objective of the proposed project?

Continue to provide "Welcome to Hunt" hunting access for big game, upland game birds, small game and predators on 3,035 acres of private land in the Heppner area (NB-02 Deer Hunt Area).

(b) How will the project benefit wildlife habitat?

The project benefits wildlife habitat through the cooperative nature of this program by continuing to provide excellent opportunities for landowners and Department personnel to work cooperatively on habitat improvement projects. Ongoing projects include CRP field improvements, annual grass treatments and invasive weed control to improve habitat for mule deer and upland game birds.

In recent years, public hunting access in the Heppner area has steadily declined, primarily due to the growth of fee-hunting operations on private lands. This project plays a critical role in maintaining a "Welcome to Hunt" program on private land that remains open to the public for hunting and other recreational uses- at no additional cost to the public. Access is offered on a "Welcome to Hunt" basis and is available year-round. Beyond preserving public access, the project strengthens relationships between landowners, the Department and the hunting community by supporting responsible use of private lands. By keeping these lands accessible to the public, the project provides significant value to local hunters and outdoor enthusiasts while promoting long-term conservation and land stewardship.

This project is an access project with minimal long-term commitments. ODFW and the landowner will work cooperatively to address any maintenance needs.

(b) What element(s) of the project will be monitored, how often, for how long?

Hunter use, satisfaction, and harvest information will be monitored annually by ODFW East Region Staff. Entry point kiosks and "voluntary" check-in / check-out stations will be monitored during the hunting and access seasons to collect and resupply A&H Access Area Daily Permits and area maps. ODFW and the Oregon State Police will include the property in the areas that are being patrolled during the hunting and access seasons. ODFW and the landowner will work cooperatively to post signs on the property and resolve any issues that may arise from the use of the property.

ODFW will provide administrative oversight of the Social Ridge Access Area, including



posting signage and conducting regular patrols to ensure compliance with area-specific and statewide hunting and fishing regulations. The Oregon State Police (OSP) will support enforcement efforts by addressing hunting violations and other regulatory infractions.

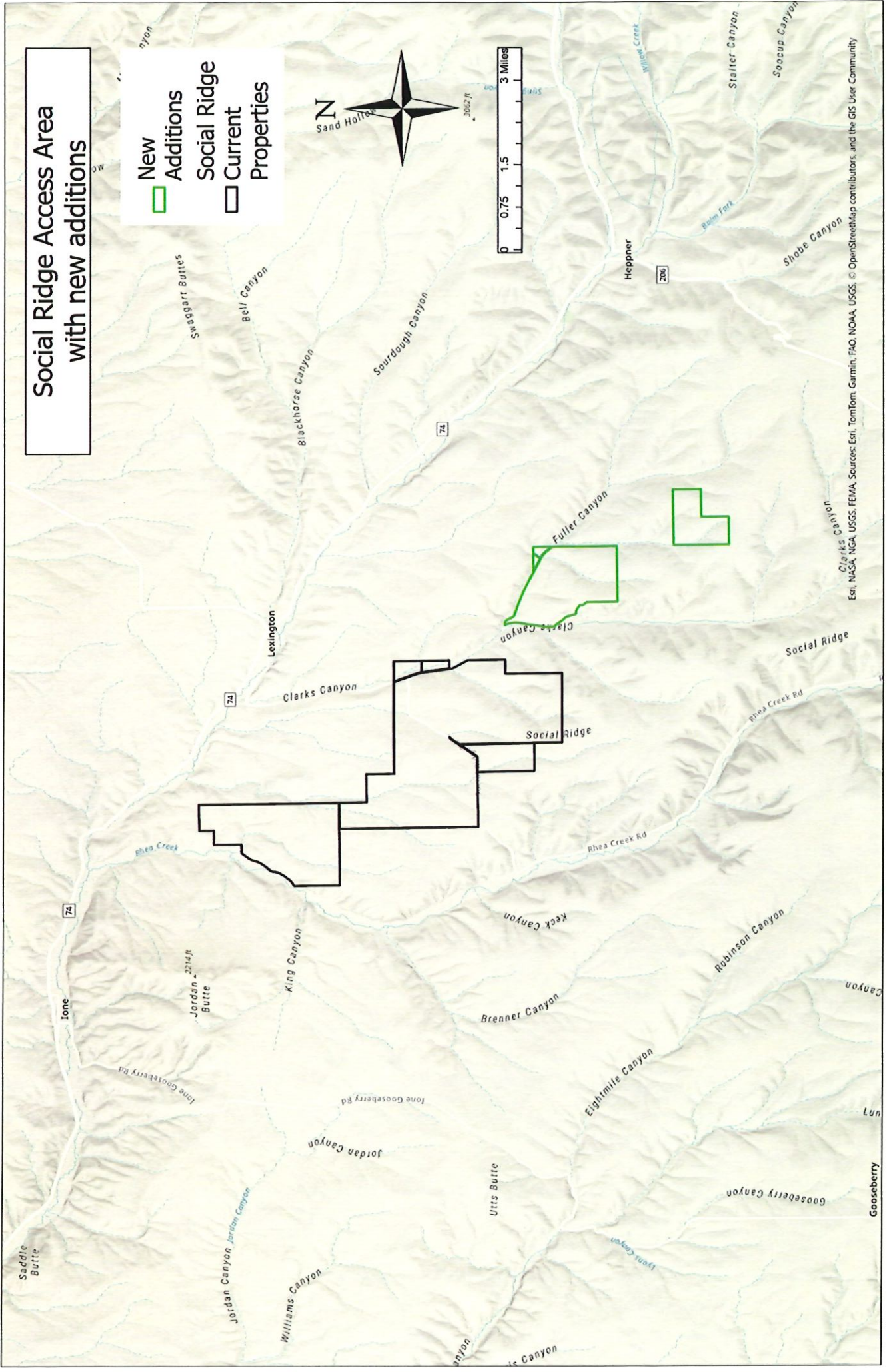
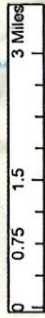
The landowner will contribute by maintaining additional signage and ensuring that their agricultural operations can continue alongside public use of the property.

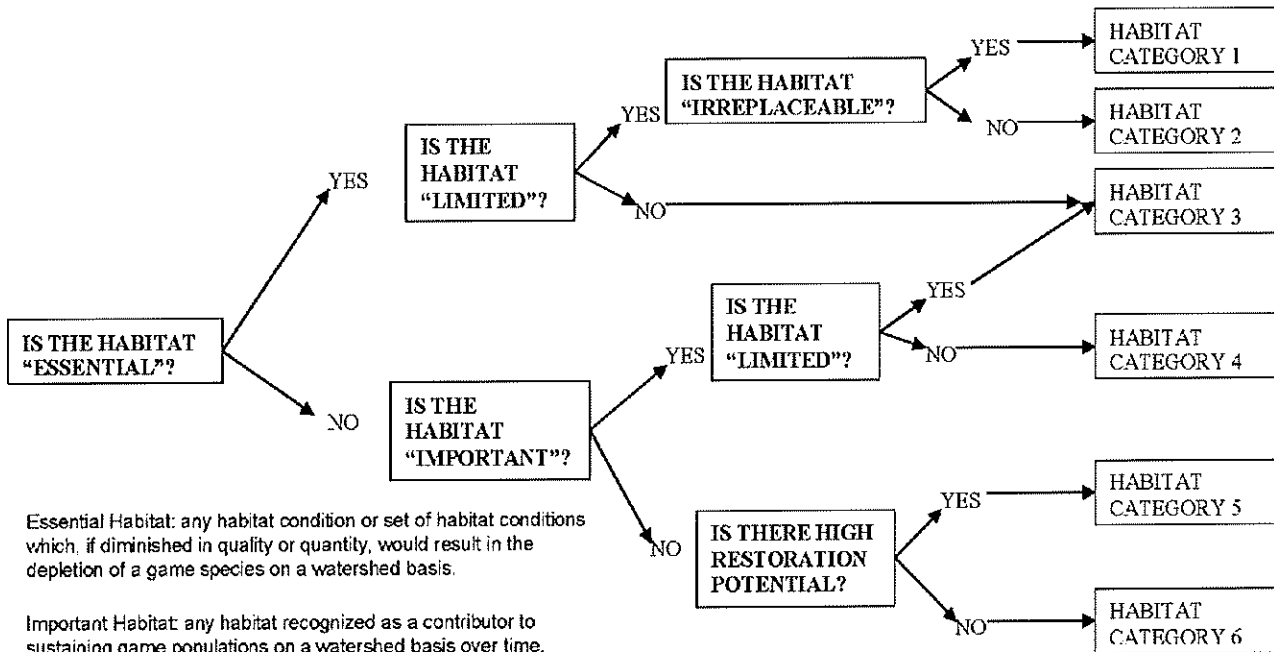

[This portion of the Social Ridge Access Area is a working wheat farm that currently encompasses 1,678 acres near the town of Heppner, OR. The area provides critical winter range](#)

for mule deer, along with valuable summer and transitional habitat. In addition to big game, Social Ridge supports a diverse range of upland bird species, including pheasant, quail, and mourning dove. Pronghorn antelope and a variety of nongame species also reside in the area. ODFW (the Department) collaborates closely with landowners and the local Soil and Water Conservation District (SWCD) to maintain and enhance wildlife habitat.

13. **Background:** Describe the project area and explain the wildlife habitat and/or access challenge or opportunity this project will address. Address how current management actions benefit public access and/or wildlife, and their habitat needs.

Access- In an area that has experienced significant declines in public access in recent years, this portion of the Social Ridge Access Area was previously enrolled in the Upland Cooperative Access Program (UCAP) as a "Welcome to Hunt" property. Continuing to build on that relationship, the landowner is seeking to enroll 1,678 acres in the Access and Habitat Program (A&H) as "Welcome to Hunt" lands for big game, upland game birds, small game and predators. Based on information generated from UCAP participation, these parcels are heavily utilized by the hunting public and support some of the highest deer hunter densities within the NB-02 Deer Hunt Area. Additionally, these lands have received some of the highest upland bird hunter use in the Heppner Area. In a hunt area that has 0% public lands, the Social Ridge Access Area continues to attract and accommodate a diverse range of users.

14. **Past A&H History:** Describe any past Access & Habitat project, especially if the proposed project deals with continuation or amendment to a past project.

The properties are working wheat farms northwest of Heppner, OR. Comprised of rangelands and row crop production, the access area provides habitat for mule deer, pheasant, quail, Hungarian partridge, chukar, small game and predators. ODFW (the Department) does not pay access payments for wheat fields in the years that they are fallowed, as they do not provide wildlife habitat. Therefore, the Department only pays for half of the wheat acres per year.

15. **Hunter Use Data:** New Projects: Must give estimates of expected usage and how usage will be assessed. Old Projects: Use Access Area Permit data, vehicle or pedestrian counts, hunter interviews, etc.

Hunter access has been provided in accordance with the Upland Cooperative Access Program agreement under a "Welcome to Hunt" classification for the 2020-2025 hunting seasons. Hunter use is high as the lands fall within the NB-02 Deer Hunt Area, which is 0% public lands. The access area will continue to provide valuable access for public hunters who would otherwise have a difficult time finding opportunities.

Currently these properties are managed through the Upland Cooperative Access Program as "Welcome to Hunt" properties. It is estimated that they see the same amount of usage as the current Social Ridge Access Area properties for deer and upland game bird hunting. Under the A&H/Open Fields program this property will be added to the Social Ridge Access Area and hunter use data will be tracked with check-in kiosks and access area permits.

Continue to provide "Welcome to Hunt" hunting access for big game, upland game birds, small game and predators on 1,678 acres of private land in the Heppner area (NB-02 Deer Hunt Area).

The project benefits wildlife habitat through the cooperative nature of this program by continuing to provide excellent opportunities for landowners and Department personnel to work cooperatively on habitat improvement projects. 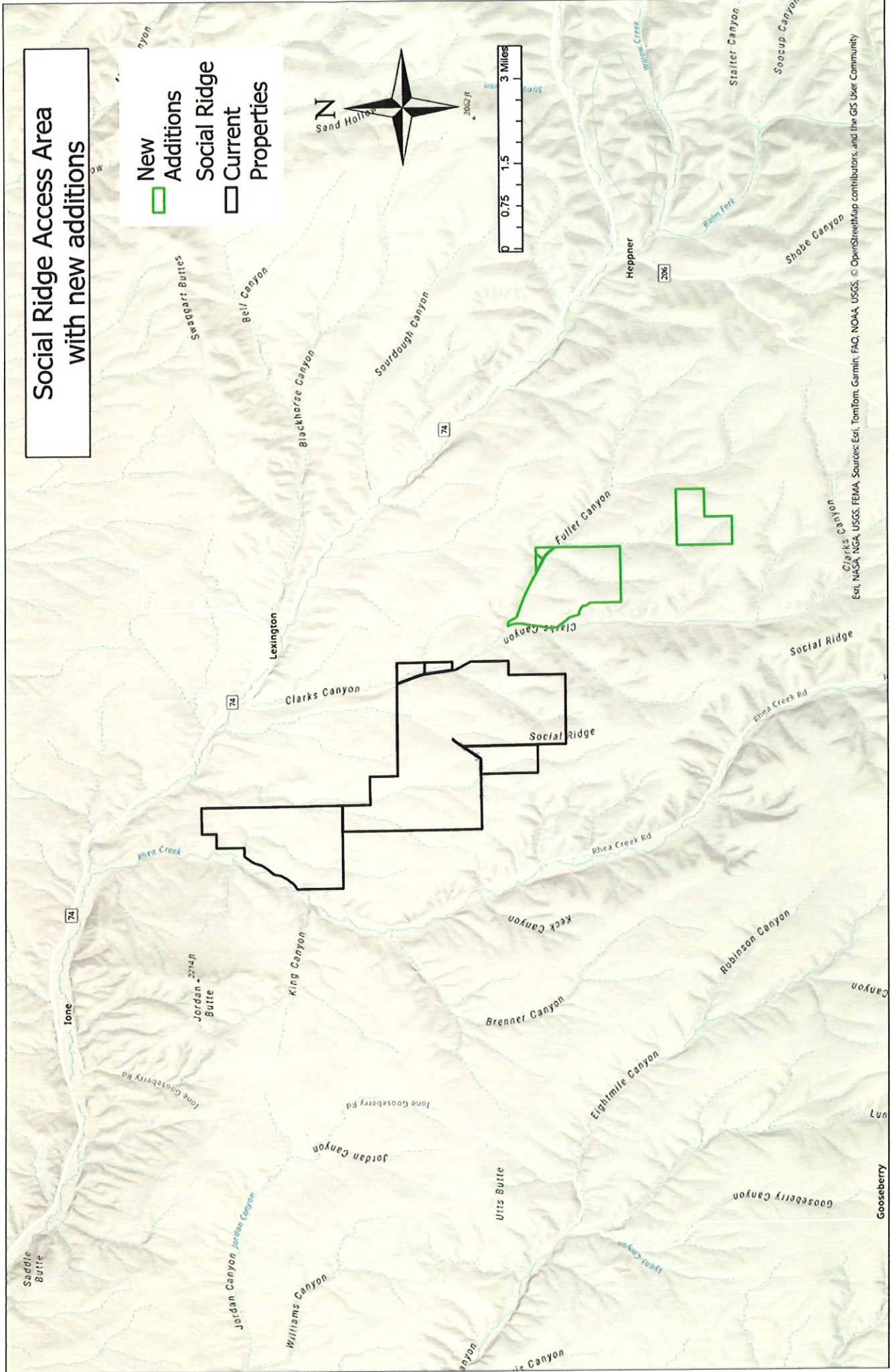
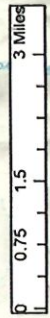

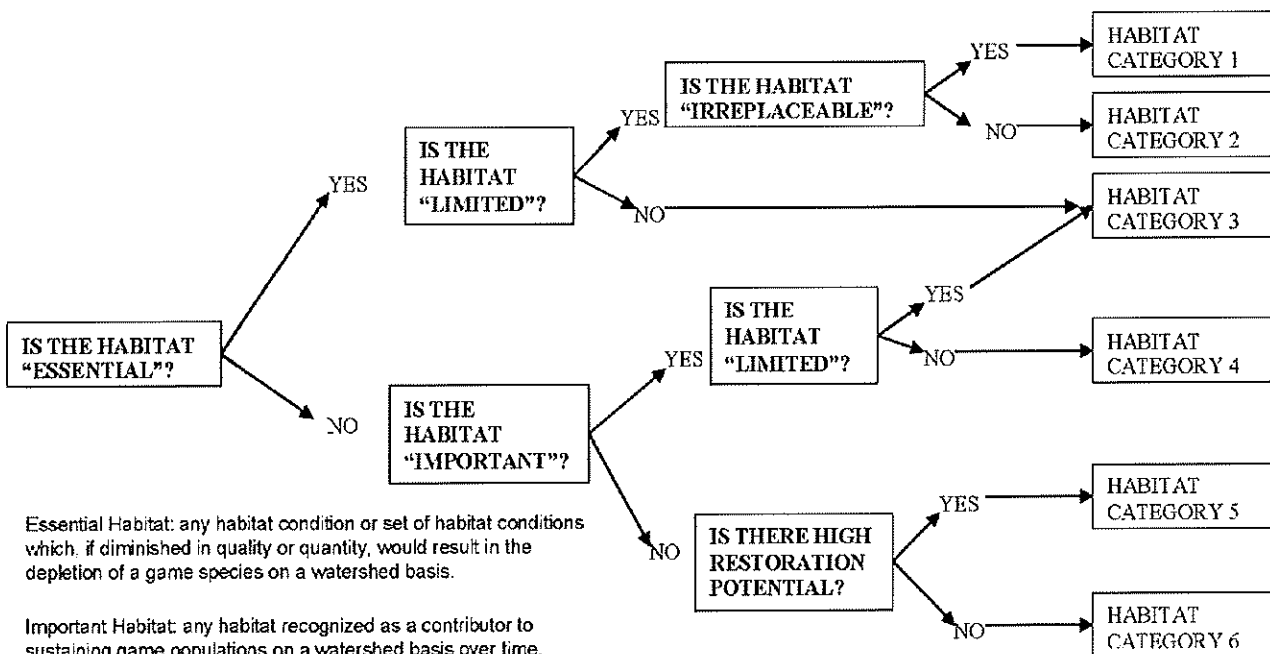

[This portion of the Social Ridge Access Area is a working wheat farm that currently encompasses 1,506 acres near the town of Heppner, OR. The area provides critical winter range for mule deer, along with valuable summer and transitional habitat. In addition to big game,](#)

Social Ridge supports a diverse range of upland bird species, including pheasant, quail, and mourning dove. Pronghorn antelope and a variety of nongame species reside in the area. ODFW (the Department) collaborates closely with landowners and the local Soil and Water Conservation District (SWCD) to maintain and enhance wildlife habitat.

13. **Background:** Describe the project area and explain the wildlife habitat and/or access challenge or opportunity this project will address. Address how current management actions benefit public access and/or wildlife, and their habitat needs.

Access- In an area that has experienced significant declines in public access in recent years, the Social Ridge Access Area continues to offer 1,506 acres of "Welcome to Hunt" hunting access for big game, upland game birds, small game and predators. This property is heavily utilized by the hunting public and supports the highest deer hunter densities within the NB 02 Deer Hunt Area. Additionally, the access area receives some of the highest upland bird hunter use in the Heppner Area. In a hunt area that has 0% public lands, the Social Ridge Access Area continues to attract a diverse range of users.

14. **Past A&H History:** Describe any past Access & Habitat project, especially if the proposed project deals with continuation or amendment to a past project.

The property is a working wheat farm north of Lone, OR. Comprised of rangelands and row crop production, the access area provides habitat for mule deer, pheasant, quail, Hungarian partridge, chukar, small game and predators. ODFW (the Department) does not pay access payments for wheat fields in the years that they are fallowed, as they do not provide wildlife habitat. Therefore, the Department only pays for half of the wheat acres per year.

15. **Hunter Use Data:** New Projects: Must give estimates of expected usage and how usage will be assessed. Old Projects: Use Access Area Permit data, vehicle or pedestrian counts, hunter interviews, etc.

Hunter access has been provided in accordance with the agreement for the 2020-2025 hunting seasons. Hunter use is forecasted to remain high as the access area falls within the NB-02 Deer Hunt Area, which is 0% public lands. The access area continues to provide valuable access for public hunters who would otherwise have a difficult time finding opportunities.

Hunter use is tracked through the collection of access area permits. The access area averaged 102 hunters per hunting season (big game/upland game bird) from 2020-2025. The Department believes that these figures are low based on the fact that there is only one entry point kiosk for all of Social Ridge and not all hunters submit permits. Staff also believe that some hunters will sign in once, but will utilize the property for multiple days. Non-hunting recreational use, such as wildlife viewing, has also remained constant. Overall, the property continues to be well utilized throughout the year by a diverse range of user groups.

Continue to provide "Welcome to Hunt" hunting access for big game, upland game birds, small game and predators on 1,506 acres of private land in the Heppner area (NB-02 Deer Hunt Area).

There is a long-standing history of elk damage in the Columbia Basin. During severe winter conditions, this project will help the Heppner District Office in addressing elk damage that is occurring on private land by providing public hunting access to private land in an area where access is otherwise very limited. ODFW is using hunters to help address these damage complaints. A hunt structure that allows hunters to pursue elk from August 1 – March 31 is currently in place. Continuing to provide greater access to private lands can increase hunter success and assist ODFW in addressing private lands damage complaints and elk distribution issues.

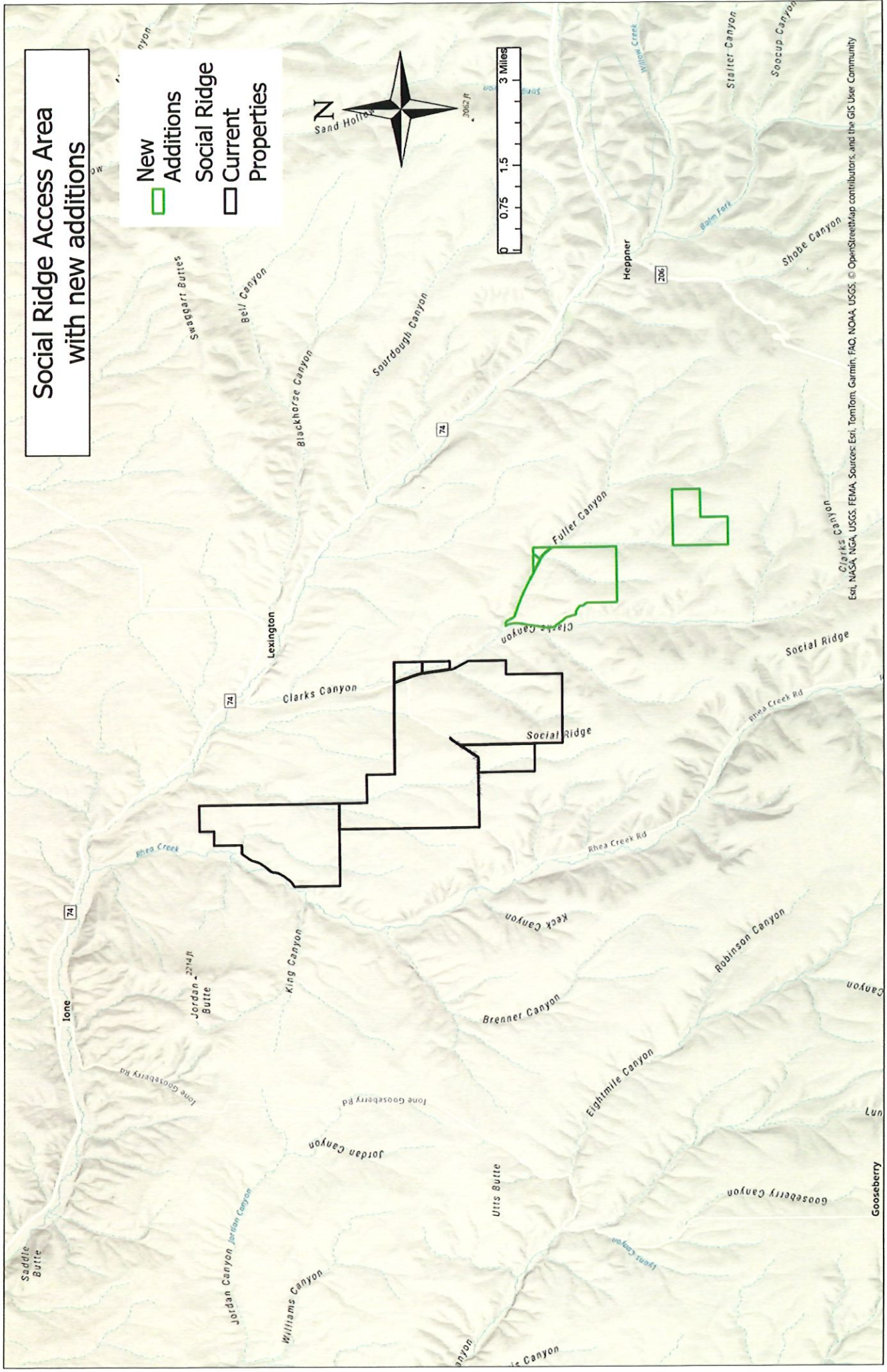
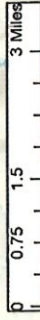

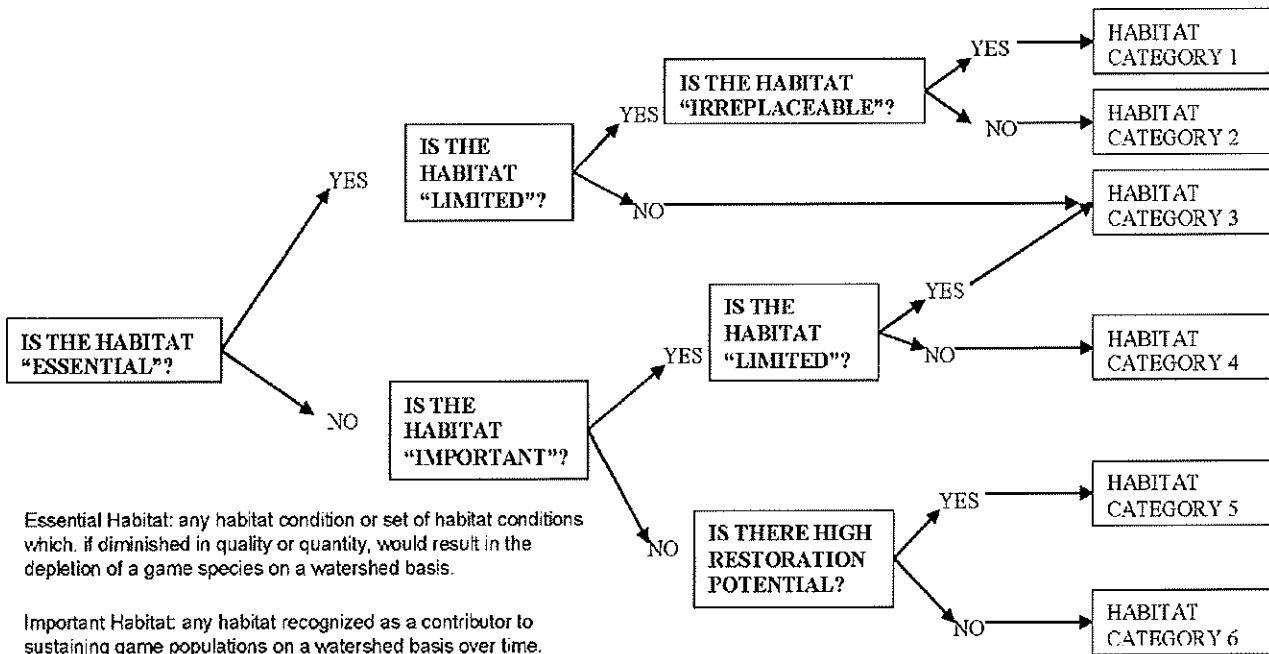
